REQUESTED ACTION

- 1. Adopt Resolution 23/24.01 (Attachment A) approving the Surface Transportation Block Grant Program (STBG) FY 2022/23 Exchange Apportionment and Allocation.
- 2. Authorize the Executive Director to sign the 2022/23 Exchange Recipient Agreement between El Dorado County Transportation Commission (EDCTC) and the City of Placerville (Attachment C).
- 3. Authorize the Executive Director to sign the 2022/23 Exchange Recipient Agreement between EDCTC and El Dorado County (Attachment D).

BACKGROUND

The Regional Surface Transportation Program (RSTP) now known as the Surface Transportation Block Grant Program (STBG) was established by California State Statute utilizing Surface Transportation Program Funds that are identified in Section 133 of Title 23 of the United States Code. The State of California allows smaller counties to exchange their apportionment of Federal STBG funds for State Highway Account funds.

DISCUSSION

El Dorado County Transportation Commission (EDCTC) distributes the STBG Exchange funds to the City of Placerville and El Dorado County as part of its responsibilities as the Regional Transportation Planning Agency (RTPA) for the Western Slope of El Dorado County. The funds are allocated according to the formula-based distribution policy approved February 3, 2011, with Resolution 10/11.16 (Attachment E). EDCTC executes agreements between EDCTC and the STBG Exchange recipients to provide contract management and oversight of the program funds.

EDCTC's share is 10% per the formula-based distribution policy. The allocation for FY 2022/23 includes reimbursements from EI Dorado County's share based on the following transactions that occurred during the fiscal year.

- At the December 2, 2022 Commission meeting, Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) Planning Programming and Monitoring (PPM) in the amount of \$43,704 was programmed to EDCTC and the remainder of the funding, \$874,084, was programmed to the EI Dorado Hills Boulevard Interchange (EDC IC) Eastbound on- and off-ramps. After the programming was approved, Caltrans notified EDCTC the PPM funds were included in the total and not in addition to the \$874,084. The entire amount went to the EDH IC project and EDCTC did not receive the PPM funds.
- 2. In August of 2022, EDCTC prepared an amendment to the 2020 Regional Transportation Plan and an addendum to the Environment Impact Report in order to add the Bass Lake Road at Bridlewood Drive Roundabout project for El Dorado County. EDCTC paid \$4,991 to a professional services firm to prepare the amendment and the addendum.

EDCTC is deducting the amount of the CRRSAA PPM funding and the cost of the professional services contract from the El Dorado County's share of STBG Exchange funding. EDCTC staff reached consensus on this repayment approach with El Dorado County Department of Transportation Director.

The 2022/23 STBG Exchange Apportionment and Allocation includes a set aside of \$100,000 for future consideration by the EDCTC for a project of regional significance. After conversations with the City and County, there is an opportunity to improve wayfinding in the Apple Hill area to help visitors navigate to businesses such as wineries, breweries, and Apple Hill farms. The \$100,000 STBG set aside could be programmed to this or another regionally significant effort as agreed upon by the City of Placerville and El Dorado County and ultimately considered for programming by the EDCTC at a future meeting.

The City of Placerville approved their 2022/23 exchange appropriation of \$200,000 for the Broadway Maintenance Project from Mosquito Road to Schnell School Road on July 11, 2023. El Dorado County approved their 2022/23 exchange appropriation of \$670,721 on June 27, 2023 as a match to the US 50 Camino Area Safety Project, Intersection Safety/Pedestrian Safety Improvements, Intersection Safety/Sight Triangle Improvements, Pleasant Valley Road Safety Improvements, and the Diamond Springs Parkway Phase 1B project.

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION APPROVING THE SURFACE TRANSPORTATION BLOCK GRANT PROGRAM FISCAL YEAR 2022/23 EXCHANGE APPORTIONMENT AND FUNDING AGREEMENTS BETWEEN EDCTC AND THE CITY OF PLACERVILLE AND EDCTC AND EL DORADO COUNTY

WHEREAS, pursuant to California Government Code, Title 7.95, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the western slope of El Dorado County; and

WHEREAS, California Government Code Section 29532.1(g), identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds; and

WHEREAS, the El Dorado County Transportation Commission, as the Regional Transportation Planning Agency, distributes the STBGP funds using the formula-based distribution policy adopted on February 3, 2011, after an agreement is executed between EDCTC and the STBGP recipient; and

WHEREAS, The City of Placerville approved their 2022/23 exchange appropriation of \$200,000 for the Broadway Maintenance Project from Mosquito Road to Schnell School Road project at the City Council meeting on July 11, 2023; and

WHEREAS, El Dorado County approved their 2022/23 exchange appropriation of \$670,721 as a match to the Intersection Safety/Pedestrian Safety Improvements in El Dorado and Diamond Springs, the Pleasant Valley Road Safety Improvements, the Intersection Safety/Sight Triangle Improvement, and the US 50/Camino Area Safety Project at the Board of Supervisor's meeting on June 27, 2023.

NOW THEREFORE, BE IT RESOLVED, that the EI Dorado County Transportation Commission make the following apportionment and allocation of FY 2022/23 STBGP Exchange funds:

- To El Dorado County Transportation Commission in the amount of \$161,963
- To the City of Placerville in the amount of \$200,000
- To El Dorado County in the amount of \$670,721

BE IT FURTHER RESOLVED, the Executive Director is authorized to sign the Agreements between EDCTC and the City of Placerville and EDCTC and El Dorado County.

AGREEMENT BETWEEN THE EL DORADO COUNTY TRANSPORTATION COMMISSION AND CITY OF PLACERVILLE FOR FY 2022/23 SURFACE TRANSPORTATION BLOCK GRANT PROGRAM & EXCHANGE FUNDS

This agreement is made on July 11, 2023 by and between the El Dorado County Transportation Commission, hereinafter referred to as "EDCTC," and City of Placerville, hereinafter referred to as "STBG Exchange Recipient."

WHEREAS, as authorized by section 182.6(g) of the Streets and Highways Code, EDCTC has entered into agreement X23-6157(081) with the State of California, through the Department of Transportation (Caltrans), to assign a defined portion of its annual Surface Transportation Block Grant Program (STBG) apportionment to Caltrans in exchange for fiscal year (FY) 2022/23 nonfederal State Highway Account funds; and

WHEREAS, EDCTC is authorized to use these exchanged funds (hereinafter STBG Exchange Funds) to assist local agencies to promote projects which otherwise qualify for STBG funds; and

WHEREAS, EDCTC is required to execute formal written agreements between EDCTC and STBG Exchange Recipients and provide oversight of the program funds; and

WHEREAS, the FY 2022/23 STBG Exchange funds will be paid to the City of Placerville per the formula based distribution policy adopted by the EDCTC on February 3, 2011 after approval by the El Dorado County Transportation Commission and execution of this agreement; and

WHEREAS, EDCTC is implementing this agreement and Exhibit A to perform contract management and oversight of the STBG Exchange Funds; and

NOW, THEREFORE, in consideration of the mutual covenants contained herein, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. The STBG Exchange Recipient agrees to use the funds only for the STBG Exchange eligible project(s) described in Exhibit A.
- 2. The projects described in Exhibit A, and the amounts allocated therefore, may be amended from time to time without changing the rest of this Agreement, by means of approval by the EDCTC Board of a revised Exhibit A, which shall be designated by a date and number (e.g., "Exhibit A-1 (DATE)").
- 3. The STBG Exchange Recipient agrees to mention EDCTC's role in funding the project in any press release or media event held by the STBG Exchange Recipient at the beginning and completion of the construction phase of the STBG funded project.
- 4. EDCTC agrees to allocate all of these Funds only for those projects implemented by cities, counties, and other STBG Eligible agencies as are authorized under Article XIX of the California State Constitution, in accordance with the requirements of Section 182.6(d)(1) of the Streets and Highways Code.

- 5. The STBG Exchange Recipient agrees to submit a status report to EDCTC by April 30 each year with the details of the STBG funding by project on Exhibit A.
- 6. STBG Exchange Recipient agrees to establish a special account within its Special Gas Tax Fund for the purpose of depositing therein all payments received from EDCTC pursuant to this agreement.
- 7. The STBG Exchange Recipient agrees to have a City Council approved budget appropriation of the STBG Exchange project(s) within three years of the date of this agreement. The expiration date of these funds will be five years from the date funds were allocated by the EDCTC. Failure to complete the STBG Exchange project(s) within the five years shall allow EDCTC to request repayment from the STBG Exchange Recipient and reprogram such Exchange Funds for other purposes.

8. COST PRINCIPLES

- A. EDCTC and STBG Exchange Recipient agree to comply with Office of Management and Budget Supercircular 2 CFR 200, Cost Principles for State and Local Government and the Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments.
- B. STBG Exchange Recipients will be obligated to agree that (A) Contract Cost Principles and Procedures, 48 CFR, Federal Acquisition Regulations System, Chapter 1, Part 31, Et Seq., shall be used to determine the allowability of individual project cost items and (B) STBG Exchange Recipients shall comply with Federal Administrative Procedures in accordance with 2 CFR 200, Uniform Administrative Requirements for Grants and Cooperative Agreements to State And Local Governments. Every sub-recipient receiving funds as a contractor or sub-contractor under this agreement shall comply with Federal administrative Requirements for Grants and Cooperative and Cooperative Agreements to State and Local Governments.
- C. Any Fund expenditures for costs which STBG Exchange Recipient has received payment or credit that are determined by subsequent audit to be unallowable under Office of Management and Budget Supercircular 2 CFR 200 are subject to repayment to EDCTC and Caltrans. The implementation of the Supercircular will cancel 49 CFR Part 18.

9. THIRD PARTY CONTRACTING

- A. STBG Exchange Recipient shall not award a construction contract over \$10,000 or other contracts over \$25,000 on the basis of a noncompetitive negotiation for work to be performed using Funds without the prior written approval of Caltrans. This provision shall not apply to professional service contracts of the type which are required to be procured in accordance with Government Code Sections 4525 (d), (e), and (f).
- B. STBG Exchange Recipient agrees that any subcontract or agreement entered into by STBG Exchange Recipient using Funds received pursuant to this Agreement shall contain all of the fiscal provisions of this Agreement; and shall mandate that travel and per diem reimbursements and third-party contract reimbursements to subcontractors will be

allowable as project costs only after those costs are incurred and paid for by the subcontractors and only if consistent with Paragraph 12, below.

C. In addition to the above, the pre-award requirements of third party contractor/ consultants with STBG Exchange Recipient shall be consistent with Local Program Procedures as published by Caltrans.

10. ACCOUNTING SYSTEM

STBG Exchange Recipient, its contractors and subcontractors, shall establish and maintain an accounting system and records that properly accumulate and segregate Fund expenditures by line item. The accounting system of STBG Exchange Recipient, its contractors and all subcontractors shall conform to Generally Accepted Accounting Principles (GAAP), enable the determination of incurred costs at interim points of completion, and provide support for project payments.

11. RIGHT TO AUDIT

For the purpose of determining compliance with this Agreement and other matters connected with the performance of STBG Exchange Recipient's contracts with third parties, EDCTC, STBG Exchange Recipient, STBG Exchange Recipient's contractors and subcontractors and Caltrans shall each maintain and make available for inspection all books, documents, papers, accounting records, and other evidence pertaining to the performance of such contracts, including, but not limited to, the costs of administering those various contracts. All of the above referenced parties shall make such materials available at their respective offices at all reasonable times for five years from the date of payment of Funds to STBG Exchange Recipient. Caltrans, the California State Auditor, or any duly authorized representative of Caltrans or the United States Department of Transportation, shall each have access to any books, records, and documents that are pertinent for audits, examinations, excerpts, and transactions, and STBG Exchange Recipient shall furnish copies thereof if requested.

12. TRAVEL AND SUBSISTENCE

Payments to STBG Exchange Recipient for travel and subsistence expenses of STBG Exchange Recipient forces and/or its contractors or subcontractors, claimed for reimbursement or applied as local match credit, shall not exceed rates authorized to be paid exempt non-represented State employees under current State of California Department of Human Resources (Cal HR) rules. If the rates invoiced are in excess of those authorized Cal HR rates, then STBG Exchange Recipient is responsible for the cost difference and any overpayments shall be reimbursed to EDCTC and Caltrans on demand.

13. PROJECT COMPLETION

STBG Exchange Recipient agrees to provide to EDCTC a report summarizing total project costs and milestones for each project using this STBG Exchange funding within sixty (60) days of completion.

14. TERMINATION DATE

This Agreement shall remain in effect for a period of five (5) years from the execution date of this Agreement.

SUBJECT: HIGHWAY INFRASTRUCTURE PROGRAM AND TRANSPORTATION DEVELOPMENT ACT BICYCLE PEDESTRIAN FUNDS PROGRAMMING

REQUESTED ACTION

Adopt Resolution 23/24.02 programming \$130,777 in Federal Highway Infrastructure Program (HIP) funds (Attachment A) and Resolution 23/24.03 programming \$84,223 in Transportation Development Act (TDA) Local Transportation Fund (LTF) Pedestrian and Bicycle funds (Attachment B) to El Dorado County Department of Transportation for Intersection Safety Improvements.

BACKGROUND

The Federal HIP was created in Section 122 in Division A of the 2010 Consolidated Appropriations Act, which authorized \$650 million with the intent to specifically fund the "restoration, repair, construction, of federal aid eligible roads, bridges, and tunnels." The Highway Infrastructure Program (HIP) has had four cycles of funding announced by Federal Highway Administration (FHWA), Federal Fiscal Years 2017/18, 2018/19, 2019/20, and 2020/21. HIP funding is distributed by FHWA and further divided by states, which are required to coordinate with the relevant Metropolitan Planning Organizations (MPOs) and/or rural planning organizations as required by the Fixing America's Surface Transportation (FAST) Act [23 U.S.C. 1101(b)].

In accordance with Transportation Development Act TDA Statute 99233.3, El Dorado County Transportation Commission (EDCTC) has the option to apportion up to two percent of the remaining LTF, after allocation of administration and planning funds, for facilities provided for the exclusive use of pedestrians and bicycles. In accordance with TDA Statute 99234(a), claims for facilities provided for the exclusive use of pedestrians and bicycles shall be filed according to the rules and regulations adopted by the transportation planning agency. EDCTC adopted programming guidelines in June 2014 (Attachment C).

DISCUSSION

On July 17, 2023, El Dorado County Department of Transportation (DOT) submitted a funding request letter to EDCTC to fully fund two small Highway Safety Improvement Program (HSIP) projects included in the DOT Capital Improvement Program (Attachment D). The two projects were advertised for construction as a single project, and bids came in higher than expected. These important projects will provide the following safety improvements:

- Construct pedestrian bulb-outs, median refuge, and user-actuated flashing beacons added to the existing uncontrolled mid-block pedestrian crossing at the intersection of Pleasant Valley Road and Oriental Street.
- Construct pedestrian bulb-outs, median refuge, and user-actuated flashing beacons added to the existing uncontrolled mid-block pedestrian crossing just east of the intersection of Pleasant Valley Road and Church Street.
- Construct a new mid-block pedestrian crossing in Diamond Springs at the intersection of Pleasant Valley Road and Racquet Way, including pedestrian bulb-outs, median refuge, and user actuated flashing beacons.

• Cut back the hill and remove several trees at the northwesterly corner of the intersection of Pleasant Valley Road and Cedar Ravine Road to improve sight distance for southbound Cedar Ravine motorists looking to turn east on Pleasant Valley Road.

El Dorado County DOT opened bids for the project on July 6, 2023. The low bid received was \$966,990, which is \$273,340 more than the engineer's estimate of \$723,650. After increasing the contingency and construction management budgets to reflect the low bid received, the project has a shortfall of \$315,000. County staff worked with Caltrans to increase the HSIP funding by \$100,000 and EDCTC has available Federal HIP funds in the amount of \$130,777 plus \$84,223 in TDA/LTF Pedestrian and Bicycle Funds which can be applied toward the pedestrian safety improvements in the project's \$315,000 shortfall. With the approval of the requested programming action, EDCTC will have utilized all available HIP funds and there will be a remaining balance of \$303,360 in TDA/LTF Pedestrian and Bicycle funds.

In the event there are remaining HIP or TDA/LTF Pedestrian and Bicycle Funds after the project is complete, those funds will return to EDCTC for future programming to another eligible project.

RESOLUTION 23/24.02

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION PROGRAMMING HIGHWAY INFRASTRUCTURE PROGRAM FUNDS

WHEREAS, pursuant to California Government Code, Title 7.95, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, it is the responsibility of EDCTC, under the provisions of the Memorandum of Understanding with the Sacramento Area Council of Governments (SACOG), to program and track projects to be funded with Highway Infrastructure Program (HIP) funds; and

WHEREAS, on July 17, 2023, the El Dorado County Department of Transportation (DOT) submitted a request to EDCTC to consider the programming of HIP funding to fully fund an intersection safety improvements project on segments of Pleasant Valley Road; and

WHEREAS, EI Dorado County DOT has identified a funding shortfall of \$315,000 to construct the project, a combination of fund sources will fully fund construction; and

WHEREAS, as of July 2023, EDCTC's available HIP fund balance is \$130,777; and

WHEREAS, this project submitted for consideration for programming has been determined to be HIP eligible; and

WHEREAS, any HIP funds remaining at the completion of the programmed project will be returned to EDCTC for re-programming to a HIP eligible project.

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION PROGRAMMING TRANSPORTATION DEVELOPMENT ACT LOCAL TRANSPORTATION FUND PEDESTRIAN AND BICYCLE FUNDS

WHEREAS, pursuant to California Government Code, Title 7.95, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, EDCTC is responsible for the planning, allocating and programming funds and for the administration of Transportation Development Act of 1971 (TDA) Funds; and

WHEREAS, in accordance with Transportation Development Act (TDA) Statute 99233.3, EDCTC has the option to apportion up to two percent of the remaining Local Transportation Fund (LTF), after allocation of administration and planning funds, for facilities provided for the exclusive use of pedestrians and bicycles; and

WHEREAS, in accordance with TDA Statute 99234(a), EDCTC has adopted programming guidelines for use of TDA/LTF Pedestrian and Bicycle Funds; and

WHEREAS, on July 17, 2023 the EI Dorado County Department of Transportation (DOT) submitted a request to EDCTC to consider the programming of TDA/LTF Pedestrian Bicycle funding to fully fund an intersection safety improvements project on segments of Pleasant Valley Road; and

WHEREAS, El Dorado County DOT has identified a funding shortfall of \$315,000 to construct the project, a combination of fund sources will fully fund construction; and

WHEREAS, as of July 2023, EDCTC's available Transportation Development Act Local Transportation Fund Pedestrian Bicycle fund balance is \$387,583; and

WHEREAS, pedestrian components of the project have been determined to be eligible for use of Transportation Development Act Local Transportation Fund Pedestrian Bicycle fund; and

WHEREAS, in the event the project does not utilize all of the programmed funding, the remaining TDA/LTF Pedestrian and Bicycle Funds will return to EDCTC for future programming.

NOW THEREFORE, BE IT RESOLVED, that the El Dorado County Transportation Commission approves the programming of \$84,223 in TDA/LTF Pedestrian and Bicycle Funds to the El Dorado County DOT for the intersection safety improvements project at various locations on Pleasant Valley Road.

BE IT FURTHER RESOLVED, that the project shall be submitted to SACOG for amendment into the Metropolitan Transportation Improvement Program, as applicable.

GUIDELINES FOR ADMINISTRATION OF TRANSPORTATION DEVELOPMENT ACT LOCAL TRANSPORTATION FUND ARTICLE 3 PEDESTRIAN AND BICYCLE FUNDING

ADOPTED JUNE 2014

TDA STATUTE

- 1. In accordance with TDA Statute 99233.3, EDCTC has the option to apportion up to two percent of the remaining Local Transportation Fund (after allocation of administration and planning) to the City and County for facilities provided for the exclusive use of pedestrians and bicycles. The eligible claimants are the City of Placerville and El Dorado County.
- 2. Of the amount made available to the City and County, five percent thereof may be expended to supplement moneys from other sources to fund bicycle safety education programs.
- 3. Funds shall be allocated in accordance with requirements described in TDA Statute 99234, Claims for Pedestrian and Bicycle Facilities as follows:
 - (a) Claims for facilities provided for the exclusive use of pedestrians and bicycles or for bicycle safety education programs shall be filed according to the rules and regulations adopted by the transportation-planning agency.
 - (b) The money shall be allocated for the construction, including related engineering expenses, of those facilities pursuant to procedures or criteria established by the transportationplanning agency for the area within its jurisdiction, or for bicycle safety education programs.
 - (c) The money may be allocated for the maintenance of bicycling trails, which are closed to motorized traffic pursuant to procedures or criteria established by the transportation-planning agency for the area within its jurisdiction.
 - (d) The money may be allocated without respect to Section 99231 and shall not be included in determining the apportionments to a city or county for purposes of Sections 99233.7 to 99233.9, inclusive.
 - (e) Facilities provided for the use of bicycles may include projects that serve the needs of commuting bicyclists, including, but not limited to, new trails serving major transportation corridors, secure bicycle parking at employment centers, park-and-ride lots, and transit terminals where other funds are unavailable.
 - (f) Notwithstanding any other provision of this section, a planning agency established in Title 7.1 (commencing with Section 66500) of the Government Code may allocate the money to the Association of Bay Area Governments for activities required by Chapter 11 (commencing with Section 5850) of Division 5 of the Public Resources Code.
 - (g) Within 30 days after receiving a request for a review from any city or county, the transportation-planning agency shall review its allocations made pursuant to Section 99233.3.
 - (h) In addition to the purposes authorized in this section, a portion of the amount available to a city or county pursuant to Section 99233.3 may be allocated to develop a comprehensive bicycle and pedestrian facilities plan, with an emphasis on bicycle projects intended to accommodate bicycle commuters rather than recreational bicycle users. An allocation under this subdivision may not be made more than once every five years.
 - (i) Up to 20 percent of the amount available each year to a city or county pursuant to Section 99233.3 may be allocated to re-stripe class II bicycle lanes.

EDCTC RULES AND REGULATIONS FOR USE OF TDA ARTICLE 3 PEDESTRIAN AND BICYCLE FUNDING, IN PRIORITY ORDER

- 1. Projects shall be:
 - Included in an adopted Bicycle Transportation Plan, Non-Motorized Transportation Plan, Transit Plan, or Pedestrian Plan, as applicable
 - Endorsed by a Council or Board, as applicable
- 2. The primary use of this fund source shall be as matching funds for projects that have a significant contribution by a local agency or have grant funding, i.e. Active Transportation Program.
- 3. A. The funding may be used to augment ongoing construction projects, i.e. road rehabilitation or construction projects that require additional funding for bicycle, pedestrian facilities or signage.
 - B. Costs may be reimbursed up to 50% to complete the environmental, design and right of way phases of a pedestrian or bicycle project to provide shelf-ready projects for future grant opportunities.
- 4. The funding may be used to for minor bicycle and pedestrian projects as follows:
 - For installation of bicycle racks or lockers
 - For installation of bicycle and pedestrian signage for bicycle routes, school zones and park and ride lots
 - For crosswalk striping, pedestrian refuges, minor bicycle lane striping
 - For maintenance of existing bicycle or pedestrian facilities
- 5. The funding may be used to supplement moneys from other sources to fund bicycle safety education programs.

Re: Funding Request to Cover High Bids

Mr. Deloria,

This letter formalizes our recent conversations regarding the El Dorado County Department of Transportation's (Transportation) request that the El Dorado County Transportation Commission (EDCTC) provide additional funding to cover higher than expected bids that were recently received on Transportation's Intersection Safety Improvements Project (Project).

The Project combines two small projects (36105061 and 36105062) in Transportation's Capital Improvement Program. The Project will provide improvements as follows:

- 1. Pedestrian bulb-outs, median refuge, and user-actuated flashing beacons added to the existing uncontrolled mid-block pedestrian crossing at the intersection of Pleasant Valley Road and Oriental Street;
- 2. Pedestrian bulb-outs, median refuge, and user-actuated flashing beacons added to the existing uncontrolled mid-block pedestrian crossing just east of the intersection of Pleasant Valley Road and Church Street;
- 3. A new mid-block pedestrian crossing in Diamond Springs at the intersection of Pleasant Valley Road and Racquet Way. The new pedestrian crossing will include pedestrian bulb-outs, median refuge, and user-actuated flashing beacons.
- 4. The hill and several trees at the northwesterly corner of the intersection of Pleasant Valley Road and Cedar Ravine Road will be cut back significantly to improve sight distance for northbound Cedar Ravine motorists looking to turn east on Pleasant Valley Road.

Bids for this Project were opened on July 6, 2023. The low bid received was \$966,990, which is \$273,340 more than the engineer's estimate of \$723,650. After increasing the contingency and construction management budgets to reflect the low bid received, the Project has a total shortfall of \$315,000. Caltrans has committed to funding \$100,000 of this shortfall, so Transportation is requesting that EDCTC fund the remaining \$215,000.

The Project is funded by the Highway Safety Improvement Program (53%) and RSTP Advance - EDCTC (47%).

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION APPROVING THE POLICY FOR FORMULA-BASED DISTRIBUTION OF RURAL REGIONAL SURFACE TRANSPORTATION PROGRAM FUNDS

WHEREAS, pursuant to California Government Code, Title 7.91, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g), identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds; and

WHEREAS, Caltrans exchanges Federal RSTP Funds for State Funds for EDCTC as a Rural Regional Transportation Planning Agency; and

WHEREAS, it is the responsibility of the El Dorado County Transportation Commission, in accordance with Caltrans Local Assistance Program Guidance, as the Regional Transportation Planning Agency (RTPA) receiving an apportionment of Rural RSTP funding, to "provide application rules for project listings" in our jurisdiction; and

WHEREAS, EDCTC and partner jurisdictions have developed a method for formula-based distribution of Rural RSTP Funds; as follows;

- To EDCTC for Overall Work Program, including: planning, programming, project monitoring, and grant matching funds, up to a maximum of 10% of available RSTP; and
- To a regional project, as determined by EDCTC jurisdictions, annually, when applicable; and
- To the City of Placerville utilizing 2 times the City's RSTP Eligible centerline mileage, applied as a percentage to available funds, or \$200,000, whichever is greater; and
- To the El Dorado County Department of Transportation, all remaining funds; and

WHEREAS, the formula shall be applied annually upon EDCTC's receipt of estimated or actual funding levels for Rural RSTP; and

WHEREAS, the policy shall be reviewed every ten years, or upon incorporation of a new jurisdiction, or at the request of the City of Placerville, El Dorado County, or El Dorado County Transit Authority; and

NOW THEREFORE, BE IT RESOLVED, that the El Dorado County Transportation Commission approves the policy for formula-based distribution of Rural RSTP funding.
