Please consider these additional comments on why you should not adopt this EIR today. Consultation should include EDC Historical Society, EDC Heritage Assoc., Friends of Historic Hangtown and Wopumnes Tribe. There has not been rigorous cumulative effects analysis on the loss of historic resources, including character, association and feeling associated with this transportation program in the RTP 2020-20240. This analysis should inform a historic preservation based alternative.

It is extremely disingenous to say you are doing public outreach when the timing of your outreach overlaps with the 2020 campaign season as well as your HIghway 50 alternatives survey. This appears very intentional and deceptive. It is a breach of duty to make it so difficult for the public to participate in such a significant programmatic planning process.

Comprehensive traffic management planning for neighborhoods is needed as mitigations for the actions in this plan to ensure safety and quality of life for the residents of the region. Many residential areas are turning into arterials due to poor transporation planning. Historic districts and neighborhoods need protection in this plan which is currently lacking.

PLEASE POSTPONE APPROVAL OF THIS EIR AND EXTEND / EXPAND THE PUBLIC ENGAGEMENT PROCESS FOR THIS TRANSPORTATION PROGRAM.

## **BACKGROUND**

The Transportation Development Act (TDA) §99238.5 requires El Dorado County Transportation Commission (EDCTC), as the Regional Transportation Planning Agency for the west slope of El Dorado County, to ensure the establishment and implementation of a citizen participation process which shall include provisions for at least one public hearing in the jurisdiction represented by the Social Services Transportation Advisory Council (SSTAC).

The El Dorado County Transit Authority (EDCTA) currently claims all TDA funds for transit purposes; therefore, the formal unmet needs process and analysis referenced in the <u>TDA Statutes and California Code of Regulations</u> no longer applies. This fact, though, does not preclude the need to identify potential transit needs and/or ways to improve the efficiency and effectiveness of existing transit service.

**CONVERSION PLAN** 

#### **REQUESTED ACTION**

By motion, ratify the El Dorado County Transit Authority Zero Emission Bus Fleet Conversion Plan Stakeholder Advisory Committee (SAC).

#### **BACKGROUND**

On October 16, 2019, El Dorado County Transportation Commission (EDCTC) applied for a Caltrans Fiscal Year 2020/2021 Road Maintenance and Rehabilitation Account – Sustainable Communities – Technical grant to fund the El Dorado County Transit Authority Zero Emission Bus Fleet Conversion Plan. On June 18, 2020, Caltrans notified EDCTC that the El Dorado County Transit Authority Zero Emission Bus Fleet Conversion Plan had been selected for funding in Fiscal Year 2020/2021 with an award of \$180,000. EDCTC committed \$25,000 in Local Transportation Funds and El Dorado County Transit Authority committed \$20,000 in State Transit Assistance funds for a combined total of \$45,000 in matching funds. On November 5, 2020, the EDCTC Board awarded the consulting contract to Stantec Consulting Services, Inc. (Stantec), for a not-to-exceed amount of \$195,000.

#### **DISCUSSION**

Public involvement and outreach are important components of the El Dorado County Transit Authority Zero Emission Bus Fleet Conversion Plan. In an effort to involve a broad range of potentially affected interests, pending the Commission's ratification, the thirty-two groups/entities/organizations listed below will be represented on the El Dorado County Transit Authority Zero Emission Bus Fleet Conversion Plan Stakeholder Advisory Committee (SAC). The project scope of work assumes a minimum of two SAC meetings and two public open houses. The date of each SAC meeting and the date of the two public open houses will be finalized pending EDCTC's consultation with the El Dorado County Transit Authority, Stantec, and AIM Consulting.

#### REQUESTED ACTION

Receive and file the Fiscal Year 2019/2020 Audit Reports.

#### **BACKGROUND**

According to the Transportation Development Act (TDA), Sections 6661, 6662, and 6751, El Dorado County Transportation Commission (EDCTC) is required to submit reports of fiscal and compliance audits to the California State Controller within 180 days following the close of each fiscal year. The fiscal and compliance audits of the financial statements of EDCTC, the Local Transportation Fund, and State Transit Assistance funds have been completed by Richardson & Company, LLP. These audits are performed in accordance with Generally Accepted Auditing Standards by a certified public accountant and include a determination of compliance with TDA rules and regulations. Pursuant to TDA statute Section 99245, EDCTC also contracts with an independent fiscal auditor to conduct certified fiscal audits of all TDA claimants in the EDCTC jurisdiction.

For Fiscal Year 2019/2020, these audit reports include:

- El Dorado County Transportation Commission
- El Dorado County Transportation Commission Local Transportation Fund
- El Dorado County Transportation Commission State Transit Assistance Fund
- El Dorado County Transit Authority (EDCTA)

The Commission has traditionally included and paid for the annual financial audit of the El Dorado County Transit Authority (EDCTA), in addition to the TDA portions of their fiscal audit. The approved EDCTC FY 2020/2021 Overall Work Program and Budget includes the expenditure for the preparation of the fiscal year 2019/2020 audits and reports for Transit and EDCTC.

#### DISCUSSION

On November 24, 2020, Richardson & Company, LLP presented the El Dorado County Transportation Commission's audit reports to Vice Chair Taylor and Commissioner Hidahl. The presented audit reports included the El Dorado County Transportation Commission, the Local Transportation Fund (LTF), the State Transit Assistance (STA) Fund and the State of Good Repair (SGR) Fund. The Auditors also presented El Dorado County Transit Authority's audit reports to EDCTA Chair Hidahl and Vice Chair Taylor.

The results of the audit were a clean opinion and compliance testing was performed where Richardson & Company, LLP determined the Commission complied with the TDA.

The Management's Discussion and Analysis beginning on page 3 presents a narrative overview and analysis of EDCTC's financial statements during the fiscal year ending June 30, 2020.

In addition to the Audit Report, independent audit firms are also required to submit communications regarding the audit directly to the governing board. This communication is included as Attachment B.

STUDY COMMUNITY OUTREACH SUMMARY REPORT

#### **REQUESTED ACTION**

Accept as final the US 50 Recreational Travel Hot Spot Transportation Management Study Community Outreach Summary Report.

#### **BACKGROUND**

In early 2018, El Dorado County Transportation Commission (EDCTC) worked closely with Caltrans to develop a scope of work for the US 50 Recreational Travel Hot Spot Transportation Management Study (study), to be led by Caltrans. This Caltrans led effort aimed at identifying issues and opportunities to improve safety, congestion, and throughput on US Highway 50 along key segments of the corridor, including the segment through the City of Placerville. Caltrans and the project team facilitated multiple Stakeholder meetings in mid-2019. The clear reaction to the preliminary efforts of the study was that the adaptive roadway strategies proposed were not enough; the stakeholders and public were interested in revisiting the possibility of major infrastructure improvements to US 50, such as a raised freeway or adding a third westbound lane.

#### **DISCUSSION**

To enhance the Caltrans effort and to better serve the interests of the City of Placerville and El Dorado County, EDCTC secured \$40,000 in Caltrans Rural Planning Assistance and \$30,000 in State Highway Account grant funding to add community outreach and alternatives analysis to the Caltrans study. The EDCTC led community outreach effort consisted of multiple meetings with stakeholders and the public, both virtually and in person. This community outreach involved surveys and outreach focused on the current conditions of US 50 through Placerville, the desired improvements, and support for various solutions.

The community outreach component evolved into a robust effort focused around two key efforts. First, alternatives presented by the public, stakeholders, and past efforts were revisited. These alternatives were evaluated by the stakeholder advisory and project development teams who then narrowed the list to four alternatives based upon technical evaluations and a reasonable likelihood that the alternative would improve traffic through Placerville. Secondly, Fehr and Peers worked with Caltrans to develop cost estimates and micro-simulations for the four alternatives. Finally, the four alternatives were presented through a virtual community workshop to the public, stakeholders, and local leaders. The entire effort has been summarized in the US 50 Recreational Travel Hot Spot Transportation Management Study Community Outreach Summary Report. Next, EDCTC will work with Caltrans, the City of Placerville, and EI Dorado County to develop long range financing strategies which may support the delivery of one of the alternatives prioritized through this effort.

SUBJECT: PROFESSIONAL SERVICES AGREEMENT: US 50 CORRIDOR SYSTEM USER

ANALYSIS, INVESTMENT STRATEGY AND ACCESS CONTROL ACTION PLAN

## **REQUESTED ACTION**

Authorize the Executive Director to enter into a professional services agreement between El Dorado County Transportation Commission (EDCTC) and Wood Rogers, to develop the US 50 Corridor System User Analysis, Investment Strategy and Access Control Action Plan for a not-to-exceed amount of \$184,945.

#### **BACKGROUND**

US 50 is the most significant and highly utilized transportation corridor in El Dorado County, providing east-west connections to Sacramento County, the State of Nevada, and east across the United States. It is the primary east west route for interregional tourism travel into the Lake Tahoe Basin. US 50 is also the major commute route to employment locations in the greater Sacramento area, and supports goods movement and agriculture in El Dorado County and the Lake Tahoe Basin.

In order to address long term problems associated with limited data availability and a need for a comprehensive investment strategy for the US 50 Corridor, EDCTC, in partnership with local and regional partners and Caltrans District 3, will conduct system user analysis, identify, and assess innovative pricing and investment strategies for the US 50 Corridor. The project will also perform data collection and develop traffic management strategies to prepare an access control action plan for future deployment of a pilot project along US 50 within the City of Placerville. The system user travel analysis will include comprehensive circulation and traffic data along US 50 to update and fill existing data gaps. Innovative pricing and investment strategies will include tolling, pricing, and other options to advance the efforts of Caltrans' US 50 Managed Lanes Feasibility Study and the ongoing EDCTC Recreation Travel Hot Spot Transportation Management Study. The access control action plan within the City of Placerville will conduct a risk assessment and evaluate the circulation impacts and procedures necessary for implementation of an innovative pilot project to close off local access to US 50 at the three signalized intersections. The access control action plan will determine the feasibility and identify necessary improvements, communication, traffic management, and safety measures to hold the signals in Placerville in a green phase for a designated time period to relieve congestion during peak periods along US 50 in the City of Placerville. The access control action plan will outline how a closure will be conducted during highly congested periods, as informed by the aforementioned system user travel analysis, to determine the effectiveness of such a strategy and identify potential lower cost congestion improvements.

#### **DISCUSSION**

EDCTC staff distributed the Request for Proposals (RFP) for the US 50 Corridor System User Analysis, Investment Strategy and Access Control Action Plan on October 8, 2020. Notice of the RFP was distributed via email to several consultants, a consultant distribution center, was published in the Mountain Democrat, and was made available online via Facebook and the EDCTC website. Staff received two proposals by the November 16, 2019 deadline, from DKS Associates and Wood Rogers. Each proposal was evaluated according to the criteria specified in the RFP by EDCTC staff as well as staff from EDCTC's planning partners.

The evaluation criteria utilized are as follows:

- Understanding the purpose and requirements of the US 50 Corridor System User Travel Analysis, Investment Strategy and Access Control Action Plan
- Familiarity with the project area and the type of issues and problems associated with the project
- Experience in transportation planning and the issues and functional area(s) to be analyzed
- Ability to meet the project's goals and objectives
- Approach to be followed and the tasks to be performed, including detailed steps, resources required, and proposed project schedule
- Qualifications, specific experience, and technical competence of the personnel to be assigned to this contract

Based upon the proposal review and interviews conducted on November 19, 2020, staff recommends Wood Rogers for this contract. Key factors considered by the review panel in making this recommendation are as follows:

- The firm has a strong understanding of the project purpose and requirements of the plan, as demonstrated by their proposed methodology to arrive at a blueprint to action for the US 50 Corridor.
- The firm has comprehensive traffic analysis and corridor planning experience.
- The firm provided a provided a scope of work that detailed the steps and approach for completion
  of tasks necessary to successfully deliver the US 50 Corridor System User Analysis, Investment
  Strategy and Access Control Action Plan,
- The firm is providing highly qualified project team and subconsultants with extensive experience in investment strategies related to tolling, managed, and express lane projects.
- The firm is including subconsultant AIM consulting to provide comprehensive Public Outreach services.
- The firm has combined strengths in engineering, traffic, multimodal corridor planning, financing strategies and public outreach.

Bryan Gant with Wood Rogers will serve as project manager for the US 50 Corridor System User Travel Analysis, Investment Strategy and Access Control Action Plan. Mr. Gant has over 21 years of experience with skills in multimodal corridor planning, traffic analysis and outreach. He combines these skills with a background rooted in design, ensuring a big-picture approach to project management.

SUBJECT: US 50 CORRIDOR PLANNING AND PROGRAMMING RECAP

#### **REQUESTED ACTION**

None. This item is for information and discussion only.

# **BACKGROUND**

Since its inception, the EI Dorado County Transportation Commission (EDCTC) has been a leading partner in planning for and programming funding to infrastructure improvements in the US 50 corridor on the West Slope of EI Dorado County. As growth in the region over the last two decades encouraged changes to travel patterns and driver behavior, EDCTC worked with local, regional, and state transportation partners to identify effective and long-lasting investments needed in the US 50 Corridor in EI Dorado County. The studies, plans, and detailed data and analysis developed during that time led to state and federal funding that constructed approximately \$262 million in transportation improvements along the US 50 Corridor in El Dorado County. The improvements included:

- US 50 Operational Improvements through Placerville
- US 50 High Occupancy Vehicle Lanes Phase 0 El Dorado Hills Interchange
- US 50 High Occupancy Vehicle Lanes Phase 1 Bass Lake Grade Improvements
- US 50 High Occupancy Vehicle Lanes Phase 2A Bass Lake Road to Cambridge Road
- US 50 High Occupancy Vehicle Lanes Phase 2B Cambridge Road to Cameron Park Drive
- Missouri Flat Interchanges Phase 1A Missouri Flat Interchange Improvements
- Missouri Flat Interchanges Phase 1B Weber Creek Bridge Replacement
- Western Placerville Interchanges Phase 1A Westbound On-Ramp at Ray Lawyer Drive
- Western Placerville Interchanges Phase 1B Fair Lane Improvements
- Western Placerville Interchanges Phase 2 Eastbound Off-Ramp, Park & Ride Lot
- Western Placerville Interchanges Phase 2.2 Eastbound On-Ramp at Ray Lawyer Drive
- Camino Safety Project Undercrossing of US 50 at Camino Heights and Median Barrier

In addition to partnering with El Dorado County, the City of Placerville, and Caltrans to make significant capital investments in the US 50 Corridor, EDCTC led several planning studies in an effort to better understand both existing and future conditions in the US 50 Corridor in order to identify the next round of infrastructure improvements needed to meet the transportation needs of our growing region. The planning efforts included:

- El Dorado County Regional Transportation Plan (2005-2025, 2010-2030, 2015-2035, 2020-2040)
- 2007 Camino Area Parallel Capacity/Safety Study
- 2010 State Route 49 Realignment Study
- 2014 Bay to Tahoe Basin Recreation and Tourism Travel Impact Study
- 2016 El Dorado County Sustainable Agritourism Mobility Study
- 2020 US 50 Recreational Travel Hot Spot Transportation Management Study Community Outreach Summary Report

EDCTC is committed to continue working with its local, regional, and state partners to plan the improvements necessary to meet the needs of all users of the US 50 Corridor, including local residents who rely on US 50 for their daily travel in and through the City of Placerville and El Dorado County.

#### **DISCUSSION**

This information item was brought forward at the request of the EDCTC at the November 5, 2020 meeting. Based on recent increases in traffic, safety concerns, and impacts to quality of life, EDCTC requested a discussion focused on US 50 in Placerville be agendized to allow for open dialogue and discussion about a path or strategy forward.

The volume of traffic and degree of congestion on US 50 through Placerville have each grown in the last few years to unprecedented levels. Now, severe congestion is no longer confined to weekends as westbound US 50 congestion, particularly in summer, has become a regular occurrence on Monday's and other weekdays, too. However, in 2020, the Covid-19 pandemic changed the way we live; where we work, go to school, and recreate. Travel patterns have been disrupted, and instead of travelling to distant destinations or not travelling at all, in 2020 people literally headed for the hills and mountains, resulting in extraordinarily high numbers of visitors from the Bay Area and Sacramento coming to El Dorado County to experience its abundant recreation and tourism destinations.

As a result, traffic and congestion on US 50 through Placerville increased dramatically during summer and fall 2020, and the City's streets and neighborhoods became clogged on weekends with US 50 drivers using Google Maps and Waze in an effort to escape the congestion on US 50. Today, local elected officials and residents are concerned about the impact that extreme levels of congestion on US 50 could have on their ability to evacuate in an emergency such as a wildfire, and its immediate and long-term impacts on local businesses, air quality, and the quality of life of residents of Placerville and El Dorado County. The extraordinary numbers of visitors now travelling the US 50 Corridor to reach destinations east of Placerville, combined with advancements in information dissemination through mobile device route direction applications such as Google Maps and Waze, has created a new challenge for managing traffic on US 50 and its spillover onto the local streets of Placerville. EDCTC staff prepared this agenda item to initiate an open discussion about EDCTC's role in planning transportation improvements along the US 50 corridor to address the issues outlined above and define the next steps in that process.
