#### **BACKGROUND and DISCUSSION**

The Transportation Development Act provides three funding sources:

- 1. Local Transportation Fund (LTF) from a quarter cent of the general sales tax collected statewide
- 2. State Transit Assistance (STA) fund from the statewide sales tax on diesel fuel
- 3. State of Good Repair (SGR) fund from a portion of the Transportation Improvement Fee created from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017

The California Department of Tax and Fee Administration (CDTFA), based on sales tax collected in each county, returns the general sales tax revenues to each county's LTF. The STA and SGR funds are appropriated to the State Controller's Office (SCO). The SCO allocates the tax revenue, by formula, to planning agencies and other selected agencies.

The El Dorado County Transportation Commission (EDCTC) is the Regional Transportation Planning Agency responsible for apportioning and administering the Transportation Development Act funds for the Western Slope of El Dorado County. The total allocation for LTF and STA were paid to El Dorado County Transit Authority (EDCTA) during FY 2019/2020.

The SGR is a funding source from a portion of the SB 1 Transportation Improvement Fee. The final amount for FY 2019/2020 is \$249,118.49 plus \$2,754.03 in interest and EDCTA is the only eligible recipient on the Western Slope of El Dorado County. EDCTA's approved 2019/2020 SGR project is Preventative Fleet Maintenance. EDCTA will consider approval of a claim for this project on October 1, 2020 in the amount of \$251,872.52 to be submitted to EDCTC for payment.

WHEREAS, interest earned in the SGR Fund for FY 2019/2020 was \$2,754.03; and

**BE IT FURTHER RESOLVED,** that allocation instructions shall be prepared for each claimant in accordance with the above, and pursuant to EDCTC rules and regulations. The Executive Director, appointed by the Commission, is authorized to sign the allocation instructions and to issue the instructions to the County Auditor to pay the claimant in accordance with the above allocations and conditions.

The El Dorado County Transportation Commission (EDCTC) is the Regional Transportation Planning Agency responsible for apportioning and administering these funds for this region. The attached Findings of Apportionment summarizes the actual amount of STA received for FY 2019/2020.

#### **State Transit Assistance (STA) Funds**

The final amount of FY 2019/2020 STA funds received was \$1,532,915.00 and interest earned in the funds was \$756.20. The entire allocation and interest total of \$1,533,671.20 has been paid to El Dorado County Transit Authority in FY 2019/2020.

SUBJECT: EL DORADO HILLS BUSINESS PARK COMMUNITY TRANSPORTATION PLAN

PROJECT AND PUBLIC OUTREACH UPDATE

#### **REQUESTED ACTION**

#### **BACKGROUND**

Beginning in early 2017, the El Dorado Hills (EDH) Business Park Owners Association started pursuing a new vision for the business park to effectively compete for and attract a variety of employment uses and instill a renewed business energy. As a result, the Business Park Owners Association approached the El Dorado County Transportation Commission (EDCTC) expressing a desire to revisit the planning of transportation as it relates to the existing and future uses and economic prosperity of the EDH Business Park. Transportation demand, active mobility, and multimodal connectivity is central to this planning effort for several reasons, including: the geographic relationship of the business park to the Capital SouthEast Connector project; and the potential for expanded transit services in the EDH area as a result of efforts to locate a regional transit center there; the proximity to a substantial number of homes, businesses, offices, retail, and other activity centers. The EDH Business Park is an area which presents an opportunity to build upon existing infrastructure to further the economic development and prosperity of Western El Dorado County. Increasing employment opportunities in El Dorado County will help to offset the existing jobs-housing imbalance and reduce vehicle miles travelled due to commuter travel to Sacramento and the Bay Area.

In collaboration with El Dorado County's planning and economic development divisions, and with the support of the Business Park Owner's Association, EDCTC prepared a Caltrans Community Based Transportation Planning grant application. In 2018, EDCTC was awarded \$144,000 in Caltrans Community Based Transportation Planning grant funding to develop the EDH Business Park Community Transportation Plan.

#### **DISCUSSION**

With the limitations related to the COVID-19 pandemic, the EDCTC and the project team have pivoted to virtual public outreach for the EDH Business Park Community Transportation Plan.

On October 22, from 5:00-6:30pm, EDCTC and the consulting team will be hosting an interactive webinar for the EDH Business Park Community Transportation Plan. In preparation for the workshop, we are producing three informational videos that highlight the following:

- Part 1) The development history and trends of the EDH Business Park
- Part 2) The changing nature of how employers and their employees are choosing to locate
- Part 3) An overview of how the transportation network can support development, growth, or expansion of the business park

Consistent with the scope of work for the grant funded project, the project team is evaluating three high level development scenarios for the business park to be discussed during the interactive webinar. Each scenario is defined by the current and potential uses within the business park and the accompanying transportation infrastructure.

The first scenario presents a status quo, it maintains the current and planned uses in place as a base line. The transportation system is primarily auto dependent with limited connections to other modes of transportation in the surrounding residential and retail developments.

The second scenario lays out a mix of uses within the undeveloped portions of the Business Park by adding housing and small amounts of commercial space supportive of the types of jobs in and around El Dorado Hills. Under this scenario, the transportation network in the business park will be retrofitted to include more bicycle lanes and paths as well as improved walking facilities. This scenario anticipates a reduction in trips by cars by allowing people to walk or bike between their place of employment and residence.

The third scenario is also a mixed-use scenario that adds housing and commercial to the undeveloped parcels in the Business Park, but encourages more intensive research and development, manufacturing, and office uses. The goal of scenario three is to provide a similar number of jobs as accommodated by the baseline scenario one. The more intense mixed land uses will also enable a higher number of people to live closer to their jobs and be able to walk or bike. This scenario would also create additional opportunities and increased ridership for the transit system enhancements planned for El Dorado Hills.

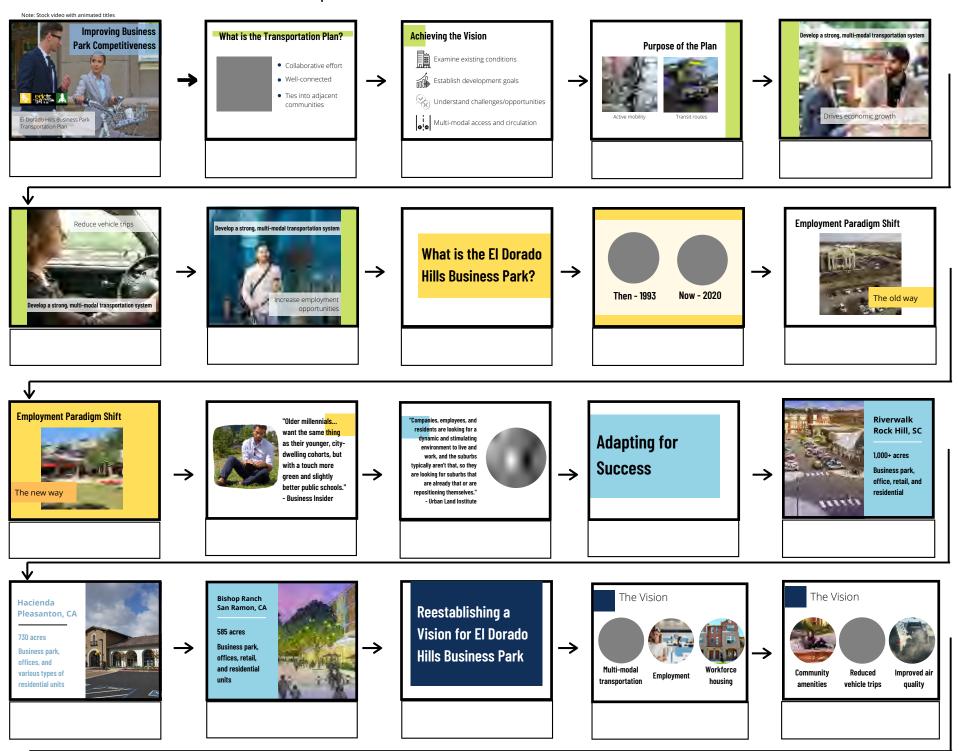

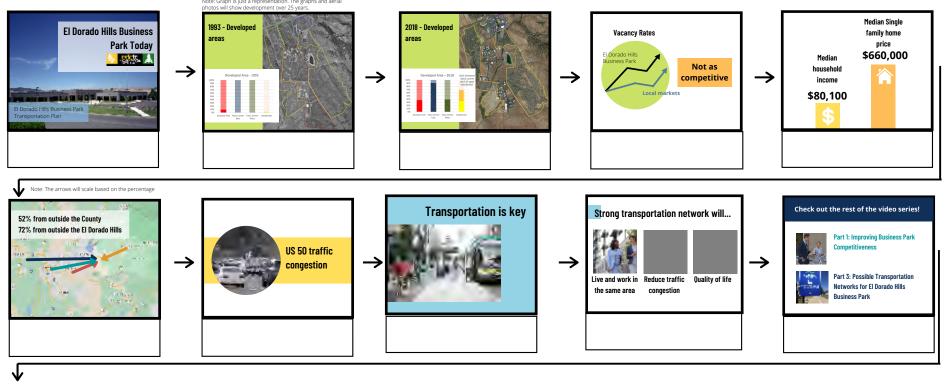
### El Dorado Hills Business Park Transportation Plan Part 1: Improving Business Park Competitiveness

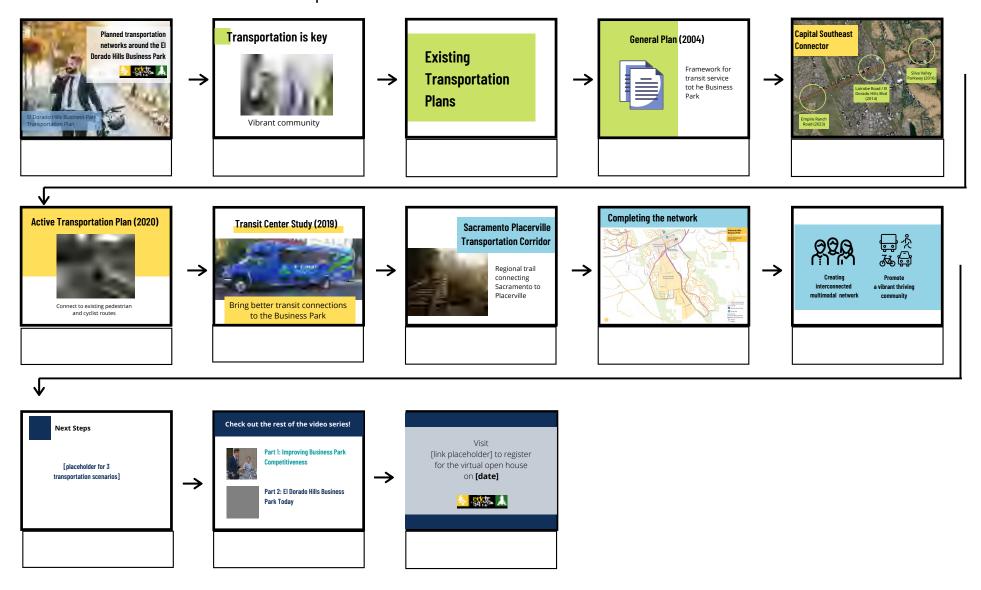

#### Part 1: Improving Business Park Competitiveness

#### 1. Title Slide

#### 2. What is the Transportation Plan?

a. El Dorado County Transportation Commission (EDCTC) and the County are collaborating with the business, property owners and the public to develop a plan that will guide the development of a well-connected transportation network through the El Dorado Hills Business Park that ties the area to adjacent residential and commercial areas.

#### 3. Achieving the Vision

a. In order to achieve this vision, the project team is examining the existing conditions of the El Dorado Hills Business Park, establishing development goals, understanding the opportunities and challenges with the area, and creating steps to implement multi-modal access and circulation in the Business Park.

#### 4. Purpose of the Plan

- a. The transportation plan, once completed, will provide a framework for improving active mobility and transit routes throughout the El Dorado Hills Business Park.
- b. As El Dorado County continues to develop and expand, a strong, multi-modal transportation network is needed to drive economic growth, reduce vehicle trips, and increase employment opportunities in the Business Park.

#### 5. What is the El Dorado Hills Business Park?

- a. When it was first developed, the EI Dorado Hills Business Park was envisioned as the largest single employment Center in Western EI Dorado County. EI Dorado Hills Business Park currently has a wide spectrum of employment types including commercial, office, and industrial.
- b. Today, it is becoming clear that the original vision for the Business Park has not been met. Vacancy rates are high, and the market rates are not as competitive as other local markets.

#### 6. Challenges with Employment

- a. Historically, companies used to decide where they would locate, and their employees would follow.
- b. In recent years, this has flipped, to where employees (particularly millennials) will decide where they want to live, then find jobs. Companies then usually locate where there is talent.
- c. Understanding where the workforce wants to live and work will help address some of the issues that we currently face in the El Dorado Hills Business Park.

#### 7. Adapting for Success

- a. In order to effectively plan a transportation network for the Business Park, we must examine what elements contribute to success in similar business parks.

- 11. Reestablishing a Vision for El Dorado Hills Business Park
  - a. Now that we have looked at some examples, what might be appropriate, relative to El Dorado County, to help transition El Dorado Hills Business Park to a thriving employment center and community?

#### 12. The Vision

a. In some of the successful business parks we studied, a multi-modal transportation network is a key component in attracting and retaining employees. Other important factors, like different housing types and community amenities for the workforce, often ensure a vibrant and thriving community. Finally, facilitating alternative modes of transportation leads to reduced vehicle trips, and ultimately improves our region's air quality.

#### 13. Key Objective

a. The overall goal of the Business Park transportation plan is to identify transportation solutions to create an environment that will better serve current and future businesses.

#### Part 2: El Dorado Hills Business Park Today

- 1. Title Slide
- 2. Developed Areas Over the Years
  - a. Over the years, El Dorado Hills has experienced development in several areas such as the El Dorado Hills Town Center and residential areas (both active adult and all-ages).
  - b. However, we have not seen the same progression for the Business Park.

#### 3. Market Observations

a. Further studies have shown that the El Dorado Hills Business Park is not as competitive when compared to other local markets in the region.

#### 4. Housing Disparity

a. Additionally, there seems to be a disparity between housing types, and job types in El Dorado Hills. With the median single-family home price of \$660,000 and a median household income of \$80,100 there is a huge gap between what employees who work in El Dorado Hills can afford to pay, and what housing options are available.

- 5. Where Are People/Employees Traveling From?
  - a. For this reason, more than half of the employees who work in El Dorado Hills Business Park commute to their jobs from outside of the county, and more than 70% commute from outside the El Dorado Hills community.
  - b. This means more traffic congestion on our roads from commuters, and more greenhouse gas emissions going into the air in our region.

#### 6. Housing Demand Moving East

- a. Projections show that the demand for housing is beginning to move east towards Cameron Park and Shingle Springs as a result of high traffic congestion.
- b. Since traffic conditions continue to worsen on US 50 as more people commute to work, a calculated approach to accommodate growth and improve our jobs/housing balance in El Dorado County is desperately needed.

#### 7. How Do We Improve the Situation?

a. Transportation is a key factor when planning for the future of El Dorado Hills Business Park. An effective multi-modal network will allow for Business Park employees to live and work in the same area, which will in turn improve traffic conditions on local roads and increase quality of life for our residents.

#### Part 3: Planned Transportation Networks Around the El Dorado Hills Business Park

- 2. Options to Improve the Business Park
  - a. Transportation is critical in developing a vibrant and thriving community in the El Dorado Hills Business Park area. However, there has not yet been a focused effort to look at transportation planning in the business park.

#### 3. Existing Transportation Plans

a. Let's go over some of these transportation plans and how they play a role in addressing the issues with the El Dorado Hills Business Park.

#### 4. General Plan (2004)

a. In 2004, El Dorado County adopted the General Plan, which provides a framework for the circulation of transit services and land use in the Business Park.

#### 5. Capital Southeast Connector

- a. In 2012 construction for the Capital Southeast Connector project began, which will ultimately create an expressway between Elk Grove and the El Dorado Hills Business Park area.
- b. The interchanges constructed as a result of this expressway will play a key role in accommodating growth in El Dorado County.

#### 6. Active Transportation Plan

a. The recently adopted regional Active Transportation Plan outlines trails and paths for pedestrians and bicyclists. The active transportation facilities that will be proposed in the El Dorado Hills Business Park Transportation Plan will ultimately connect to existing pedestrian and bicycle routes in the area.

#### 7. Transit Center Study

a. The 2019 Transit Center study evaluated six locations in the El Dorado Hills area to potentially become the County Line Multi-Modal Transit Center. The study outlined steps toward implementation of a regional mobility hub that would bring better transit connections to areas near the Business Park.

#### 8. Sacramento Placerville Transportation Corridor

a. Finally, the Sacramento Placerville Transportation Corridor includes a proposal for a regionally significant trail connecting Placerville to Folsom.

#### 9. Completing the Network

- a. Many of the previously mentioned projects provide the groundwork for achieving the goal of creating an interconnected and multi-modal transportation network in the El Dorado Hills Business Park.
- 10. The Transportation Plan will play a key role in achieving the vision of improving jobs housing balance, creating economic opportunities, and promoting a vibrant and thriving community in El Dorado Hills.
