SUBJECT: AB 361 REMOTE TELECONFERENCING

REQUESTED ACTION

Adopt Resolution 22/23.01 making findings and declaring intent to continue remote meetings pursuant to Government Code section 54953(e) due to the Governor's COVID-19 State of Emergency Proclamation and state and local recommendations related to physical distancing.

BACKGROUND

Effective October 1, 2021, assembly Bill (AB) 361 modified the provisions of the Ralph M. Brown Act ("the Brown Act") related to holding teleconference meetings during a proclaimed state of emergency when state or local officials have imposed, or recommended measures related to physical distancing which warrant holding meetings remotely.

The modifications to the requirements of the Brown Act related to open public meetings which due to the COVID-19 pandemic and which may continue under AB 361 include the following:

- Waiving the requirement that the notice of each meeting location be provided for those members of the legislative body (board or committee) participating in the meeting;
- Waiving the requirement that each meeting location be accessible to members of the public;
- Waiving the requirement that members of the public be able to address the legislative body (board and committee) at each meeting location;
- Waiving the requirement that agencies post agendas at all meeting locations; and
- Waiving the requirement that at least a quorum of the legislative body (board and committee) participate from locations within the boundaries of the territory over which they exercise jurisdiction.

El Dorado County Public Health Officer's Recommendations for Safe Board and Commission Meetings During COVID-19 Pandemic dated September 30, 2021, makes the following recommendations to allow virtual-attendance meetings to continue:

- Offer attendees a remote access option to the extent possible, while meeting the intent of the Brown Act about transparency and full participation;
- Arrange seating to encourage staff and members of the public to physically distance;
- Clearly post messages instructing people not to enter meeting venues when they feel unwell and to follow current guidelines for face-coverings, vaccination, and testing, when applicable.

DISCUSSION

If the Commission desires to continue to meet utilizing the relaxed teleconference meeting rules, AB 361 requires an ongoing finding every 30 days that the Commission has reconsidered the circumstances of the state of emergency and that the emergency continues to impact the ability to "meet safely in person," or that state of local officials continue to recommend measures to promote social distancing. Gov. Code 54953(e)(3).

In response to improving conditions, Governor Newsom issued Executive Order N-04-22 on February 25, 2022, which lifted many of the provisions related to the emergency while maintaining certain measures to support the ongoing response and recovery effort. Although a portion of the emergency provisions have been lifted the Governor's March 4, 2020, State of Emergency Proclamation as it related to the COVID-19 pandemic remains active.

Recently local and state rules related to COVID-19 and wearing face masks have also been updated. On February 28, 2022, the California Department of Public Health updated its Guidance for the Use of Face Masks. Although face masks are now recommended, and not required, in most indoor settings for vaccinated and unvaccinated individuals, in workplaces employers remain subject to the CalOSHA Emergency Temporary Standards. Section 3205 of the CalOSHA Emergency Temporary Standards continues to regulate Close Contacts, within 6 feet of another, and physical distancing continues to be recommended. These CalOSHA requirements remain in effect until December 2022.

The Governor's state of emergency remains, and the CalOSHA Regulations related to social distancing remain in place. Furthermore, the County of El Dorado Public Health Officer's September 30, 2021, recommendations related to AB 361 meetings remain in place. Based on these regulations the findings to support teleconference only meetings pursuant to section 54953(e)(1) can continue to be made.

Although there is an indication that adverse cases and impacts are decreasing, there remains risks associated with COVID-19, the ability to meet in person, and the State regulations impose of recommend measures to promote social distancing. Agency staff is continuing to monitor the status of the Governor's state of emergency proclamation, state regulations and orders related to social distancing, and health and safety conditions related to COVID-19 and confirms that said conditions continue to exist that warrant remote teleconferencing meetings.

It is recommended that the Commission find that state and local officials continue to impose or recommend measures to promote social distancing, and the conditions continue to impact the ability to meet safely in person; therefore, the next regularly scheduled Commission meeting will be a remote meeting and the Commission will continue to consider the status of the ongoing emergency and facts related to the health and safety of meeting attendees due to COVID-19.

RESOLUTION 22/23.01

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION MAKING FINDINGS AND DECLARING TO CONTINUE REMOTE TELECONFERENCE MEETINGS PURSUANT TO GOVERNMENT CODE 54953(e) DUE TO THE THREAT OF COVID-19

WHEREAS, pursuant to California Government Code, Title 7.95, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated Regional Transportation Planning Agency (RTPA) for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds and administration of the Transportation Development Act of 1971 (TDA), as amended thereafter; and

WHEREAS, On March 4, 2020, Governor Newsom issued a Proclamation of State of Emergency in response to the COVID-19 pandemic; and

WHEREAS, the proclaimed state of emergency remains in effect; and

WHEREAS, on March 17, 2020, Governor Newsom issued Executive Order N-29-20 that suspended the teleconferencing rules set forth in the California Open Meeting law, Government Code section 54950 et seq. (the "Brown Act"), provided certain requirements were met and followed; and

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order N-08-21 that clarified the suspension of the teleconferencing rules set forth in the Brown Act, and further provided that those provisions would remain suspended through September 30, 2021; and

WHEREAS, effective October 1, 2021, AB 361 allows local legislative bodies to continue to allow remote meetings during a proclaimed state of emergency, if "state or local officials have imposed or recommended measures to promote social distancing"; and

WHEREAS, on September 30, 2021, the El Dorado County Public Health Officer released "Recommendations for Safe Board and Commission Meetings During COVID-19 Pandemic" supporting compliance with AB 361; and

WHEREAS, the COVID-19 virus continues to pose imminent risk to health and safety and directly impacts the ability of the public and the Commission to meet safely in person, accordingly, the Commission hereby recognizes the proclamation of state of emergency by the Governor of the State of California and the regulations of CalOSHA recommending physical distancing;

WHEREAS, EDCTC has an important governmental interest in protecting the health, safety, and welfare of those who participate in meetings of EDCTC's legislative body subject to the Brown Act; and

WHEREAS, as a consequence of the emergency related to COVID-19, to allow for physical distancing and remote meeting attendance, the Commission intends to continue to invoke the provisions of AB 361 as provided in Government Code section 54953, subd. (e) and such meetings of the Agency shall comply with the requirements to provide the Commission members and the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953.

NOW THEREFORE, BE IT RESOLVED, by the El Dorado County Transportation Commission as follows:

1. The foregoing recitals are true and correct.
2. The meetings of the Commission, including this meeting, may be held with relaxed teleconference rules pursuant to the provisions of subdivision (e) of Government Code section 54953 due to the impacts of COVID-19, the Governor’s state of emergency proclamation, state and local recommendations and the importance of physical distancing to minimize any potential adverse health and safety risks.
3. EDCTC Commissioners hereby consider the current conditions of the state of emergency and the state and local recommendations and regulations related the social distancing and reauthorizes remote teleconference meetings.
4. Staff is hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings of the Commission in accordance with subdivision (e) of the Government Code section 54953 and other applicable provision of the Brown Act for remote only teleconference meetings.
5. Staff is further directed to continue to monitor the conditions and health and safety conditions related to COVID-19, the status of the Governor’s state of emergency, the local orders related to physical distancing, and the state regulations related to social distancing, and present to the Commission at its regularly scheduled meeting the related information and recommendations for remote only meetings pursuant to the provisions of Government Code Section 54953(e) and to extend the time during which the Commission may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.

These policies, concerning both internal and external social media management, are important to ensure the public engagement and social media tools are used appropriately, in alignment with the purpose of EDCTC, and remain professional and effective. Once approved, the Social Media Policy will be posted on social media outlets and on the EDCTC website.

REQUESTED ACTION

Adopt Resolution 22/23.02 (Attachment A) allocating Senate Bill 1 State of Good Repair 2022/23 Funds to the El Dorado County Transportation Commission.

BACKGROUND

On April 28, 2017, Governor Brown signed Senate Bill (SB) 1 (Chapter 5, Statutes of 2017), known as the Road Repair and Accountability Act of 2017. SB 1 will provide approximately \$54 billion in new transportation funding over the next ten years to repair highways, bridges, and local roads, to make strategic investments in congested, commute, and freight corridors, and to improve transit service. SB 1 includes the State of Good Repair (SGR) Program which is an investment in public transit that provides approximately \$105 million annually to the State Transit Assistance Account. The goal of the SGR Program is to provide funding for capital assistance to rehabilitate and modernize California's existing local transit systems.

The SGR Program is funded from a portion of a Transportation Improvement Fee on vehicle registrations due on or after January 1, 2018. A portion of the fee is transferred to the State Controller's Office (SCO) for the SGR program. The SCO allocates SGR funds under the State Transit Assistance Program formula to eligible agencies pursuant to Public Utilities Code (PUC) Section 99312.1. Half of the funds are allocated according to population under PUC Section 99313 and half are allocated according to transit operator revenues under PUC Section 99314.

Each year the SCO publishes estimated fiscal year SGR funding levels per PUC 99313 and 99314 according to population and farebox revenues. Per PUC Section 99312.2(c), the only entities eligible to receive direct allocations from the SCO under Sections 99313 and 99314 shall be transportation planning agencies, county transportation commissions, and the San Diego Metropolitan Transit Development Board. El Dorado County Transportation Commission (EDCTC), as a transportation planning agency and transportation commission, is eligible to receive direct allocations from the SCO under Sections 99313 and 99314. As a bus transit operator El Dorado County Transit Authority is an eligible sub-recipient.

EDCTC as the recipient agency must submit a list of proposed SGR projects to Caltrans prior to receiving an apportionment of SGR funds in a given fiscal year. Each project proposal must include the project's description and location, a proposed schedule for the project's completion, the estimated useful life of the improvement, and the sub-recipient. Caltrans reviews the project list to ensure it meets the requirements of the SGR Program and then provides the SCO with a list of eligible recipients with approved project lists. The SCO issues and releases PUC Sections 99313 and 99314 payments to the eligible recipient's County Treasurer's Office on a quarterly basis. Each county is expected to sub-allocate the funding pursuant to PUC 99314 to the applicable transit operator according to the amounts provided by the SCO and instructions provided by EDCTC.

DISCUSSION

On January 31, 2022, the State Controller’s Office provided the following estimate of the amount of SGR funds available to be allocated to EDCTC in FY 2022/23:

- PUC 99313: \$266,917
- PUC 99314: \$18,380
- Total Allocation: \$285,297

Pursuant to PUC 99312.19d0(1), prior to receiving an apportionment of the SGR monies from the SCO for FY 2022/23, EDCTC must submit to Caltrans a list of projects proposed to be funded with the SGR funds. The SGR Program project list must be submitted to Caltrans by September 1, 2022, for EDCTC to be eligible to receive FY 2022/23 SGR funding. The project list shall include the following:

- A cover letter on agency letterhead with the original signature of the Executive Director authorizing and approving the list of projects for funding.
- A signed and dated board resolution authorizing the list of projects for SGR funding commitment.
- A proposed list of projects to utilize at a minimum the estimated amount of funding available to the agency for the upcoming fiscal year.

The proposed list of projects must include the following information:

1. Project Title
2. Proposed Project Description
3. Proposed Project Schedule
4. Project Location
5. Estimated Project Cost by Fiscal Year
6. Estimated Useful Life of the Improvement
7. Description of Projected Benefit Outcome

EDCTC, in consultation with El Dorado County Transit Authority, identified the following two projects to be funded with FY 2022/23 SGR funds:

While El Dorado County Transit Authority plans to expend all the FY 2022/23 SGR funds on the Bus Parking Lot Rehabilitation project, the Fleet Repair and Rehabilitation project is included on the project list to provide flexibility in the expenditure of SGR funds if necessary. Pending the EDCTC Board’s approval of the proposed SGR list of projects, EDCTC staff will coordinate with El Dorado County Transit Authority staff to complete Caltrans’ Project List Template and submit it with the signed cover letter and signed and dated EDCTC Board Resolution to Caltrans by September 1, 2022.

WHEREAS, EDCTC consulted with the sole transit operator in the EDCTC region, the El Dorado County Transit Authority, to identify two projects, *Bus Parking Lot Repair and Rehabilitation* and *Fleet Repair and Rehabilitation* to comprise the list of proposed projects to be funded with the Fiscal Year 2022/23 apportionment made available to the region per PUC 99313 and 99314; and

WHEREAS, EDCTC determined that the *Bus Parking Lot Repair and Rehabilitation* and *Fleet Repair and Rehabilitation* projects are consistent with the 2020-2040 El Dorado County Regional Transportation Plan, the SGR Program Guidelines, and are eligible SGR Program projects.

NOW, THEREFORE, BE IT RESOLVED, the El Dorado County Transportation Commission authorizes *Bus Parking Lot Repair and Rehabilitation* and *Fleet Repair and Rehabilitation* as the list of projects for funding with Fiscal Year 2022/23 SGR apportionment made available to the region per Public Utilities Code 99313 and 99314.

NOW, THEREFORE, BE IT FURTHER RESOLVED THAT, the EDCTC Executive Director will submit to the California Department of Transportation by September 1, 2022, the authorized list of projects to be funded with the Fiscal Year 2022/23 SGR apportionment made available to the region per Public Utilities Code 99313 and 99314.

REQUESTED ACTION

- 1) Adopt Resolution 22/23.03 programming \$7,541,014 in CMAQ funding to projects and programs to be completed or administered by Sacramento Area Council of Governments (SACOG), City of Placerville, and El Dorado County Department of Transportation (Attachment A); and
- 2) Recommend the Bass Lake/Bridlewood Roundabout Project for Amendment into the 2020-2040 Regional Transportation Plan and for future programming of \$744,400 in CMAQ funds; and
- 3) Adopt Resolution 22/23.04 approving the re-programming of \$223,000 in CMAQ funds from the Merrychase/Country Club Drive Bicycle and Pedestrian Project to the El Dorado Trail Halcon Road to Ponderado Class I project (Attachment B).

BACKGROUND

As the Regional Transportation Planning Agency (RTPA) charged with programming federal and state transportation funding for the west slope of El Dorado County, El Dorado County Transportation Commission (EDCTC) is responsible for the programming of Federal CMAQ funds to projects or programs. The CMAQ program supports transportation projects or programs that demonstrate proven air quality emission reduction benefits by reducing congestion or vehicle emissions through transit services, congestion management, or active transportation. In accordance with Federal Guidelines, programming of CMAQ funds must consider quantitative data that demonstrate a project's emission reduction benefits.

EDCTC staff estimated future available funding levels and requested approval of the release of a competitive Call for Projects for CMAQ funding. With the Commission's approval of the application process, selection criteria, and selection committee agencies in April of 2022, the Call for Projects for \$8,285,414 in CMAQ funding was made available. The transportation funding application and information packet were posted on the EDCTC webpage and distributed to EDCTC agency partners and jurisdictions. Eligible applicants include El Dorado County, the City of Placerville, El Dorado County Transit Authority, Caltrans, SACOG, and the Air Quality Management Districts in the region.

EDCTC received ten applications for CMAQ funding by the June 10, 2022, deadline. The applications requested a total of \$9,216,078 from an available \$8,285,414 in CMAQ funds. Eight of the potential projects included a request to utilize Toll Credits as match for the Federal CMAQ funding. The use of Toll Credits removes the burden of providing local matching funds from the applicant but reduces the available EDCTC CMAQ capacity.

DISCUSSION

A selection committee consisting of members from EDCTC, El Dorado County Air Quality Management District, and Sacramento Area Council of Governments met digitally on three occasions

to review and score the project applications. All of the potential projects were determined to be eligible for CMAQ funding as presented. In accordance with Commission direction, the criteria listed below were utilized for the evaluation and scoring of project applications by the selection committee members:

- Project meets the requirements of the funding source
- Project Need/Benefit
- Cost Effectiveness
- Project Readiness
- Demonstrated Ability to Deliver a Federally Funded Project
- Community Support/Multi-Jurisdictional Projects
- Inclusion in Local/Regional Plan

The selection committee members completed a thorough review and discussion of each application and the projects were ranked in conjunction with the selection criteria. Attachment C summarizes all project applications and provides information about each potential project including; project rank, project sponsor, project name, project summary, selection committee total score, CMAQ funding amount requested, prior CMAQ funding awarded to the project, total project cost, project evaluation category, cost effectiveness of CMAQ funds, emission reduction benefits, and a sum of all requested funds; including Toll Credits.

Based upon the selection committee's review, EDCTC staff recommends that the following projects be programmed with CMAQ funding, as displayed in Table 1 below:

The programming of the seven projects listed in Table 1 provides all requested funding for the projects ranked 1-7 in the competitive CMAQ application process and leaves an available \$1,088,737 for consideration. Table 2 below outlines a scenario for funding two of the three lower ranked projects.

The recommendation in Table 2 allows for the Bass Lake at Bridlewood Roundabout Project to be fully funded, as it is the next highest-ranking project. However, the Bass Lake Roundabout Project is not included in the 2020-2040 Regional Transportation Plan (RTP) and would have to be amended into the current plan before it can be programmed with Federal CMAQ Funds. This is not an issue from a timing standpoint, as funding in this Call for Projects is being made available through 2026. EDCTC will need to go through an administrative process to obtain Board approval of the RTP amendment, and project specific environmental analysis will need to be completed. EDCTC staff can work through this administrative amendment and environmental process within the context of the currently approved Overall Work Program and Budget, and it would not require additional funding. In the event that the Commission recommends the Bass Lake Roundabout for the requested funding amount of \$744,400 today, EDCTC staff will bring it back to the Commission at a later date for amendment into the 2020-2040 RTP and formal programming.

The Table 2 recommendation also partially funds the request for the Diamond Springs Pedestrian Improvements Project with \$344,337 in CMAQ funds, leaving the project underfunded by \$430,664 but providing a base level of funding for the County to begin environmental and design work while leveraging future grant opportunities.

The last recommendation, outlined in Table 3 below, provides \$223,000 in CMAQ funding to the El Dorado Trail Halcon – Ponderado segment. The project will be programmed with de-obligated funding made available as a result of cost savings on the recently completed Merrychase/Country Club Drive Bicycle and Pedestrian Project. This will provide additional construction funds to the project to leverage future grant opportunities.

The members of the EDCTC Technical Advisory Committee (TAC) discussed the recommended CMAQ programming outlined in Tables 1, 2 and 3 at their meeting on July 25, 2022. The members of the TAC support the staff recommended programming of CMAQ funds.

In the event that projects experience cost-savings, any unutilized CMAQ funds will be de-obligated and returned to EDCTC for reprogramming in a future Call for Projects, depending on the outcome of the FHWA/Caltrans Corrective Action anticipated for a decision later this fall.
