BACKGROUND

The Regional Surface Transportation Program (RSTP) was established by California State Statute utilizing Surface Transportation Program Funds that are identified in Section 133 of Title 23 of the United States Code. The State of California allows smaller counties to exchange their apportionment of federal RSTP funds for State Highway Account funds. The Fixing America's Surface Transportation Act (FAST ACT) changed the name of the RSTP funding to STBG.

DISCUSSION

The El Dorado County Transportation Commission (EDCTC) distributes the STBG funds to the City of Placerville and El Dorado County as part of its responsibilities as the Regional Transportation Planning Agency (RTPA) for the Western Slope of El Dorado County. EDCTC executes an agreement between EDCTC and the STBG recipients to provide contract management and oversight of the funds. The agreement includes Exhibit A programming the funds to projects and the agreement allows for changes to the distribution of project funding with an amendment to Exhibit A.

El Dorado County Board of Supervisors approved the First Amendment to the FY 2018/19 and FY 2019/20 Agreements on September 26, 2023. These Amendments move remaining funding from the Green Valley Road/Indian Creek Bridge Replacement project and the Green Valley/Mound Springs Creek Bridge Replacement project to the Diamond Springs Parkway Phase 1B project in order to maximize the use of the funds prior to the expiration date.

The Fixing America's Surface Transportation Act (FAST ACT) changed the name of the RSTP funding to STBG.

DISCUSSION

The El Dorado County Transportation Commission (EDCTC) distributes the STBG funds to the City of Placerville and El Dorado County as part of its responsibilities as the Regional Transportation Planning Agency (RTPA) for the Western Slope of El Dorado County. EDCTC executes an agreement between EDCTC and the STBG recipients to provide contract management and oversight of the funds. The agreement includes Exhibit A programming the funds to projects and the agreement allows for changes to the distribution of project funding with an amendment to Exhibit A.

The FY 2022/23 agreement was approved at the August 3, 2023 Commission meeting. Funding in the amount of \$100,000 was reserved for a regional project for the US 50 Camino Signage and Wayfinding Mitigation Plan. EDCTC applied for a Rural Planning Assistance (RPA) grant and the STBG funds were reserved to complete this project in the event the RPA grant was not awarded. EDCTC was successful in obtaining the RPA grant for \$85,000 with a match of \$9,400. El Dorado County Department of Transportation (DOT) agreed to use \$9,400 of the STBG Exchange funds for the match. The remaining amount of \$90,600 will be added to the Diamond Springs Parkway Phase 1B project in this amendment. El Dorado County DOT will add this amendment to a future Board of Supervisors agenda.

SUBJECT: TRANSIT AND INTERCITY RAIL CAPITAL PROGRAM AND ZERO EMISSION

TRANSIT CAPITAL PROGRAM FISCAL YEAR 2023/24 FUNDING ALLOCATION

REQUESTED ACTION

Adopt Resolution 23/24.09 (Attachment A) allocating \$9,085,857 in Fiscal Year (FY) 2023/24 Transit and Intercity Rail Capital Program Funds (TIRCP) and \$971,781 in FY 2023/24 Zero Emission Transit Capital Program Funds (ZETCP) to the El Dorado County Transit Authority (EDCTA).

BACKGROUND

The Transit and Intercity Rail Capital Program (TIRCP) was created by Senate Bill (SB) 862 (Chapter 36, Statutes of 2014) and modified by SB 9 (Chapter 710, Statutes of 2015), to provide grants from the Greenhouse Gas Reduction Fund (GGRF) to fund transformative capital improvements that will modernize California's intercity, commuter, urban rail systems, and bus and ferry transit systems, to significantly reduce emissions of greenhouse gases, vehicle miles traveled, and congestion.

AB 102 (Chapter 38, Statutes of 2023) and SB 125 (Chapter 54, Statutes of 2023) amended the Budget Act of 2023 to appropriate \$4,000,000,000 of General Fund to the TIRCP over the next two fiscal years as well as \$910,000,000 of GGRF funding and \$190,000,000 of Public Transportation Account (PTA) funding over the next four fiscal years to establish the Zero-Emission Transit Capital Program (ZETCP). SB 125 provided additional direction with regards to the funding appropriated in the Budget Act of 2023. It created specific categories for funding as follows:

- 1. \$3,995,000,000 over the next two fiscal years (FY 2023/24 and FY 2024/25) shall be distributed pursuant to a population-based formula to regional transportation planning agencies (RTPA) as defined in Section 7 of these guidelines. The bill authorizes RTPAs to use the moneys for high-priority transit capital projects consistent with the uses allowed in Cycle 6 of the TIRCP, which includes existing projects seeking to maintain or obtain federal or local funding commitments, project development for major projects that are seeking to enter or have already entered project development with federal partners, or for new TIRCP projects. As in Cycle 6, all capital projects must both increase ridership and reduce greenhouse gas emissions, in common with traditional TIRCP project requirements. The funding may also be used to fund transit operating expenses that prevent service cuts and increase ridership for operators within the RTPA's jurisdiction, subject to compliance with requirements and further detail described in Section 6 of the TIRCP guidelines.
- 2. \$1,100,000,000 over the next four fiscal years (FY 2023/24 through FY 2026/27) shall be for the establishment of the Zero-Emission Transit Capital Program (ZETCP) and requires funds under the program to be allocated to RTPAs pursuant to a population-based formula and another formula based on transit operator revenues within the jurisdiction of these RTPAs, as specified (the formula described is consistent with the current State Transit Assistance formula). The bill authorizes RTPAs to use the moneys for zero emission transit equipment, including, but not limited to, zero-emission vehicles and refueling infrastructure and, subject to compliance with requirements described in Section 6 of the TIRCP guidelines, to use those moneys to fund transit operating expenditures that prevent service reduction or elimination in order to maintain or increase ridership.

DISCUSSION

Eligible recipients of TIRCP and ZETCP funding are RTPAs, as defined in Section 13987(j) of the Government Code. TIRCP funding will be allocated in both FY 2023/24 and FY 2024/25 to RTPAs according to a population-based formula after each recipient first receives \$300,000 of base funding. ZETCP funding over the four years from FY 2023/24 to FY 2026/27 will be allocated to RTPAs pursuant to a population-based formula and another formula based on transit operator revenues within the jurisdiction of individual RTPAs. This formula matches the approach used to calculate State Transit Assistance (STA) distribution. RTPAs have the discretion to suballocate or distribute funds within their region based on local needs, existing procedures, policies, or priorities, as long as required SB 125 program requirements and goals are met, including addressing how operating needs are expected to be met with SB 125 and/or other resources.

El Dorado County Transportation Commission (EDCTC) received notification that the TIRCP Final Guidelines were approved on September 29, 2023, confirming the FY 2023/24 TIRCP and ZETCP allocation amounts. As the RTPA, it is EDCTC's role to allocate TIRCP and ZETCP funding to each project sponsor under the authority of EDCTC. According to the TIRCP Final Guidelines, EDCTC's allocation for FY 2023/24 TIRCP is \$9,085,857 and \$971,781 for FY 2023/24 ZETCP. Since EDCTA is the only transit operator in the EDCTC region, staff is recommending the funds be allocated to EDCTA.

EDCTA plans to use the \$9,085,857 in FY 2023/24 TIRCP and \$971,781 in FY 2023/2024 ZETCP funds to deliver two capital projects that are consistent with TIRCP and ZETCP guidelines and are based on recommendations contained in the 2019 Western El Dorado County Short- and Long-Range Transit Plan and the 2021 EDCTA Zero Emission Bus Fleet Conversion Plan. The capital projects are:

- 1. Purchase of zero-emission buses, including installation of the equipment and infrastructure necessary to operate and support zero-emission buses
- 2. Demonstration project

Per the TIRCP and ZETCP guidelines, each RTPA seeking allocation of funding shall complete an Initial Allocation Package by December 31, 2023. Each Allocation Package shall include, as applicable, the following:

- Signed Cover Letter
- Allocation Package Narrative Explanation
- Allocation Package Detailed Project Description
- ZETCP Project Summary Fact Sheet
- Summary Excel table including the proposed uses of TIRCP and ZETCP funds by fiscal year of availability
- Regionally representative transit operator data

EDCTC will submit the Allocation Package by December 31, 2023, and the requested funding will be allocated to EDCTC no later than April 30, 2024.

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION ALLOCATING FISCAL YEAR 2023/24 TRANSIT AND INTERCITY RAIL CAPITAL PROGRAM AND ZERO EMISSION TRANSIT CAPITAL PROGRAM FUNDING TO THE EL DORADO COUNTY TRANSIT AUTHORITY

WHEREAS, pursuant to California Government Code, Title 7.95, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated regional transportation planning agency for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds; and

WHEREAS, on September 29, 2023, the California State Transportation Agency approved the Budget Act of 2023 SB 125 Formula-Based Transit and Intercity Rail Capital Program (TIRCP) and Zero Emission Transit Capital Program (ZETCP) Final Guidelines and allocation amounts for the 2023/24 fiscal year (FY); and

WHEREAS, EDCTC is responsible for allocating TIRCP and ZETCP funds to each project sponsor under the authority of EDCTC; and

WHEREAS, EDCTC has determined that a total of \$9,085,857 in TIRCP FY 2023/24 funds and \$971,781 in ZETCP FY 2023/24 funds are available for transit purposes, subject to consistency with the California State Transportation Agency's SB 125 TIRCP and ZETCP Guidelines; and

WHEREAS, the El Dorado County Transit Authority (EDCTA) is an eligible project sponsor and may receive state funding from the TIRCP and ZETCP for transit projects; and

WHEREAS, EDCTA has determined two appropriate TIRCP and ZETCP projects consistent with the 2019 Western El Dorado County Short- and Long-Range Transit Plan and 2021 Zero Emission Bus Fleet Conversion Plan and TIRCP and ZETCP Guidelines; and

WHEREAS, the two appropriate TIRCP and ZETCP projects are: 1) The purchase of zero-emission buses, including installation of the equipment and infrastructure necessary to operate and support zero-emission buses, and 2) A demonstration project; and

WHEREAS, EDCTA, as the sole transit operator in the EDCTC region, is designated the project sponsor; and

WHEREAS, the EDCTC wishes to delegate authorization to execute documents and any amendments thereto to the EDCTA Executive Director.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the EI Dorado County Transportation Commission that the fund recipient, EDCTC, and the fund sub-recipient, EDCTA, agree to comply with all conditions and requirements set forth in the Budget Act of 2023 SB 125

Formula-Based Transit and Intercity Rail Capital Program (TIRCP) & Zero Emission Transit Capital Program (ZETCP) Final Guidelines and applicable statutes, regulations, and guidelines for all TIRCP and ZETCP funded transit projects.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the EDCTC Executive Director and the EDCTA Executive Director be authorized to execute all required documents of the TIRCP and ZETCP and any Amendments thereto with the California State Transportation Agency.

RATIFICATION OF ADVISORY COMMITTEE

REQUESTED ACTION

Commence the update of the 2025-2045 El Dorado County Regional Transportation Plan (RTP) and ratify the RTP Advisory Committee Member Matrix.

BACKGROUND

Every Regional Transportation Planning Agency is required by law to conduct long-range planning to ensure that the region's vision and goals are clearly identified and to ensure effective decision making relative to implementation of the stated vision and goals. The California statute relating to the development of the RTP is primarily contained in Government Code Section 65080. The RTP is an important policy document based on the unique needs and characteristics of El Dorado County. The RTP impacts a region's economy, environment, public health and safety, and social equity future, along with communicating a regional vision to the state and federal government. The RTP supports the State's goals as enumerated in California Government Code (GC) Section 65041.1, 49 U.S.C., 5303(i), 23 U.S.C., 134, and 23 U.S.C., 150.

The RTP will be prepared in accordance with the California Transportation Commission guidelines, which are currently being updated and are anticipated for adoption in December 2023. While the guidelines include both state and federal requirements, RTPAs have the flexibility to be creative in selecting transportation planning options that best fit the region's needs. The 2023 Draft RTP Checklist contained in Attachment A must be submitted to Caltrans with the Draft and Final RTP. The purpose of the checklist is to establish a minimum standard for developing the RTP.

Transportation projects and programs must be listed in the RTP as well as the SACOG Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS), and the Federal Metropolitan Transportation Improvement Program to allow cities, counties, and transit operators to be eligible for federal funds for capital improvements. Furthermore, any capital projects are required to meet air quality conformity standards as outlined by the federal Environmental Protection Agency and implemented by SACOG.

DISCUSSION

EDCTC staff will prepare the 2025-2045 RTP over the course of the next two years, with an adoption in the fall of 2025. While the RTP looks toward a 20-year planning horizon, through the development of this update it is important to celebrate the many completed projects improving transportation since the adoption of the 2020-2040 RTP. Staff will provide a presentation on completed projects as a component of the first advisory committee meeting and to the Commission thereafter. Attachment B outlines the RTP schedule with detailed tasks to be completed and anticipated dates for public presentations. The 2025-2045 RTP update will align with the SACOG Blueprint (SACOG's Metropolitan Transportation Plan/Sustainable Communities Strategy (MTP/SCS) update. In November of 2022, the SACOG Board of Directors authorized staff to pursue state legislation to extend the MTP/SCS schedule to move the plan adoption date from spring 2024 to fall 2025. The recent approval of AB 350 provided SACOG with the legislative authorization needed to remain compliant with state

law for an additional two years. In accordance with the SACOG and EDCTC Memorandum of Understanding, EDCTC utilizes the population, transportation modeling, and growth forecasts prepared by SACOG.

Public involvement is critical to the success of the RTP process. EDCTC engages the public early and often to ensure they have ownership in the process and end result. Regional Transportation Planning Agencies are required to implement a public involvement process including opportunities for private and public operators of transit and freight, tribal governments, local communities, the general public, and other interested/affected parties (Title 23 Sec. 134(g) (4); Title 23 Sec 135 (e); and Title 23 CFR 450.316 (b) (1) (c)). The RTP shall provide for complete information, timely notice, full public access to key decisions, reasonable public access to technical and policy information, and explicit consideration of public input, in addition to an effort to seek out and consider the needs of those traditionally underserved by existing transportation systems.

EDCTC will continue to utilize an RTP Advisory Committee as a focal point of our public involvement process because of the positive results achieved through the RTP processes conducted in previous updates.

REQUESTED ACTION

BACKGROUND

The State Transportation Improvement Program (STIP) is the biennial five-year plan adopted by the California Transportation Commission (CTC) of future allocations of state transportation funds for state highway improvements, intercity rail, and regional highway, bicycle, pedestrian, and transit improvements. The five-year 2024 STIP cycle begins in Fiscal Year (FY) 2024/25 and extends through FY 2028/29. The regional agency element of the STIP is referred to as the Regional Transportation Improvement Program (RTIP). The El Dorado County Transportation Commission (EDCTC), as the Regional Transportation Planning Agency for the western slope of El Dorado County, is required by state law to adopt a RTIP every two years. The proposed RTIP should be approved by the EDCTC Board at the December 2023 meeting and submitted to the CTC before December 15, 2023. EDCTC's RTIP, upon adoption by the CTC, represents western El Dorado County's portion of the larger statewide STIP.

The projects contained within EDCTC's 2024 proposed RTIP come from public processes and approvals of EDCTC's 2020 Regional Transportation Plan, SACOG's Metropolitan Transportation Plan/Sustainable Communities Strategy, Caltrans' planning documents, and the Capital Improvement Programs of the City of Placerville, County of El Dorado, and El Dorado Transit Authority.

EDCTC 2018 RTIP Funding

On August 16, 2017, the CTC released the 2018 Draft STIP Fund Estimate, which included an estimate of county and interregional shares. Based on the fund estimate, EDCTC's estimated STIP share was \$0 through FY 2021/22 due to being advanced \$5.179 million for WPI Phase 2.

Planning, Programming, and Monitoring (PPM)

The EDCTC 2018 RTIP included the following programming of Planning, Programming and Monitoring funds during the five fiscal years of the 2018 STIP cycle:

EDCTC 2020 RTIP Funding

On August 14, 2019, the CTC released the 2020 Draft STIP Fund Estimate, which included an estimate of county and interregional shares. Based on the fund estimate, EDCTC's estimated STIP share in FY 2024/25 at the end of the five-year 2020 STIP cycle was \$2.369 million. EDCTC chose to carry the 2020 STIP share forward to the 2022 STIP.

Planning, Programming, and Monitoring (PPM)

The EDCTC 2020 RTIP included the following programming of Planning, Programming and Monitoring funds during the five fiscal years of the 2020 STIP cycle:

EDCTC 2022 RTIP Funding

On August 18, 2021, the CTC released the 2022 Draft STIP Fund Estimate, which included an estimate of county and interregional shares across the state. Based on the fund estimate, EDCTC's estimated STIP share at the end of the five-year 2022 STIP in FY 2026/27 was \$5,318,000. Additionally, EDCTC received an apportionment of \$874,084 in Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) STIP funds. After a joint consultation between the City of Placerville, El Dorado County, El Dorado Transit, and EDCTC, all parties agreed to the following 2022 STIP programming:

- Carry the 2022 STIP share forward to the 2024 STIP
- Program \$874,084 of CRRSAA STIP funds to the El Dorado Hills Boulevard Interchange Improvements Project – Phase 2B

Planning, Programming, and Monitoring (PPM)

The EDCTC 2022 RTIP proposes to include the following programming of Planning, Programming and Monitoring funds during the five fiscal years of the 2022 STIP cycle:

EDCTC 2024 RTIP Funding

On August 16, 2023, the CTC approved the 2024 STIP Fund Estimate, which included an estimate of county and interregional shares across the state. Based on the fund estimate, EDCTC's estimated STIP share at the end of the five-year 2024 STIP in FY 2028/29 is \$11,135,000. However, in accordance with Streets and Highways Code Section 188.8(j), the 2024 STIP Guidelines authorize a region for a county with a population with less than one million to ask the CTC to advance an amount beyond its county share with the caveat that any amount proposed beyond the region's STIP share target depends on the availability of the STIP's program capacity.

Following consultation with the City of Placerville, El Dorado County, and El Dorado Transit Authority to identify regionally significant projects, EDCTC staff proposes advancing EDCTC's STIP share to FY 2031/32 for a STIP programming capacity of \$31,427,500 to program STIP funding to the following projects:

- Program \$10,430,150 of 2024 STIP funds to the El Dorado Hills Boulevard Interchange Improvements Project – Phase 2B
- Program \$14,875,000 of 2024 STIP funds to the US 50 Ponderosa Interchange Phase 1A, North Shingle
- Program \$2,212,500 of 2024 STIP funds to the US 50 Ponderosa Interchange Phase 1B, Durock

• Program \$4,000,000 of 2024 STIP funds to the Western Placerville Interchanges Phase 2.3, Westbound Off Ramp

As stated previously, any amount of STIP funding proposed beyond EDCTC's 2024 STIP target of \$11,135,000 depends on the availability of the STIP's program capacity. Therefore, in case the CTC is unable to accommodate EDCTC's request to advance its STIP share by the requested amount, the four projects proposed above are listed in order of programming priority as agreed to by the City of Placerville and El Dorado County.

Planning, Programming, and Monitoring (PPM)
