STATE TRANSIT ASSISTANCE FUNDS, AND STATE OF GOOD REPAIR FUNDS

REQUESTED ACTION

Adopt Resolution 25/26.16 approving the Transportation Development Act Fiscal Year (FY) 2026/27 Apportionment and Allocation for Local Transportation Funds, State Transit Assistance Funds, and State of Good Repair Funds.

BACKGROUND and DISCUSSION

The Transportation Development Act (TDA) provides three funding sources:

1. Local Transportation Fund (LTF) from a quarter cent of the general sales tax collected statewide.
2. State Transit Assistance fund (STA) from the statewide sales tax on diesel fuel.
3. State of Good Repair (SGR) from a portion of the Transportation Improvement Fee included in Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017.

The California Department of Tax and Fee Administration (CDTFA), based on sales tax collected in each county, returns the general sales tax revenues to each county's LTF. The State Controller's Office (SCO) allocates the STA tax and the SGR revenue, by formula, to planning agencies and other eligible agencies. Statute requires that 50% of STA and SGR funds be allocated according to population and 50% be allocated according to operator revenues from the prior fiscal year.

The El Dorado County Transportation Commission (EDCTC) is the Regional Transportation Planning Agency (RTPA) responsible for apportioning and administering these funds for this region. The attached Findings of Apportionment summarize the estimates for FY 2026/27.

The LTF allocation purposes, in order of priorities, as identified by law, are as follows:

1. Transportation Development Act fund administration (by EDCTC and the County Auditor);
2. Planning and programming undertaken by EDCTC (up to 3% of the fund);
3. Pedestrian and bicycle projects (optional, up to 2% of the funds remaining, after administration and planning);
4. Public transportation operations (including new transit services that have been identified by the Commission as "unmet transit needs" that are "reasonable to meet"); and,
5. Other transportation purposes (including additional transit and bicycle facilities, and streets and roads). The Commission may only apportion (and subsequently may only approve claims for) "other transportation purposes" when all other uses of the funds, to the limits described above, have been exhausted.

EDCTC allocates the LTF funds, as determined by population, for the western slope region of El Dorado County and the Tahoe Regional Planning Agency allocates the LTF funds, as determined by population, for the eastern slope of El Dorado County. For FY 2026/27, the County Auditor estimates EDCTC's share of LTF revenues for apportionment available to program is \$7,560,014.

Administration, Planning, Programming

The County Auditor has estimated \$12,000.00 for administration from the estimated FY 2026/27 LTF revenue total. This amount is reimbursed to the County Auditor and is not included in EDCTC's Overall Work Program.

The EDCTC FY 2026/27 Overall Work Program and Budget includes administration, planning, programming, and the annual payment to SACOG for a total of \$753,832. EDCTC LTF funds are used throughout the work program to support planning activities and serve as the required local match for state and federal grant funds. In accordance with the Commission's Final Memorandum of Understanding with SACOG, EDCTC is obligated to allocate \$100,000.00 annually for transportation planning and programming activities for FY 2024/25, with subsequent annual increases based on the California Consumer Price Index. As a result, the FY 2026/27 allocation to SACOG is \$106,296.

Additionally, according to EDCTC's Transportation Development Act Local Transportation Fund Distribution Policy approved at the April 4, 2024, Board meeting establishing an operations contingency, to be adjusted annually to maintain a balance which equals 20% of EDCTC annual operating costs. The FY 2026/27 allocation is \$15,000. This will provide EDCTC with contingency in the event of unforeseen or unexpected fluctuations in costs, revenue, or other circumstances.

Non-Motorized – Pedestrian and Bicycle Facilities (Article 3)

State law offers EDCTC an option to apportion up to 2% of the LTF (after administration and planning) to the City and County for facilities provided for the exclusive use of pedestrians and bicycles. The Commission primarily uses these non-motorized funds to provide matching funds for federal and state grants, such as Congestion Mitigation and Air Quality and Active Transportation Program (ATP) grants. The 2026/27 allocation totals \$137,949.56.

Public Transportation – Transit (Article 4)

The El Dorado County Transit Authority notified the Commission staff that their claim for FY 2026/27 LTF funds will be \$6,653,232.44 for operating expenses. A contingency of the Article 4 funds up to a maximum of \$4,000,000 is retained in the LTF fund's unreserved fund balance for transit's future needs.

Other Transportation (Article 8)

No LTF funds remain available for Article 8 – Other Transportation purposes. If LTF funds were available for the fiscal year, the funds would be apportioned to the City of Placerville and the County of El Dorado by population for all purposes necessary and convenient to the development and operation of the public transportation system, including road rehabilitation, maintenance, and repair.

State Transit Assistance Funds (STA)

The estimated FY 2026/27 STA funds available for the El Dorado County Transit Authority is \$1,722,451.

State of Good Repair (SGR)

The estimated FY 2026/27 SGR funds available for the El Dorado County Transit Authority is \$337,624. Funds will be reimbursed to EDCTA after Commission approval of a claim for an approved SGR project.

RESOLUTION 25/26.16

RESOLUTION OF THE EL DORADO COUNTY TRANSPORTATION COMMISSION APPROVING THE TRANSPORTATION DEVELOPMENT ACT FISCAL YEAR 2026/27 APPORTIONMENT AND ALLOCATION FOR LOCAL TRANSPORTATION FUNDS, STATE TRANSIT ASSISTANCE FUNDS, AND STATE OF GOOD REPAIR FUNDS

WHEREAS, pursuant to California Government Code, Title 7.95, Section 67950, the El Dorado County Transportation Commission (EDCTC) was created as a local planning agency to provide regional transportation planning for the area of El Dorado County, exclusive of the Lake Tahoe Basin; and

WHEREAS, California Government Code Section 29532.1(g) identifies EDCTC as the designated Regional Transportation Planning Agency (RTPA) for El Dorado County, exclusive of the Lake Tahoe Basin; and is responsible for the planning, allocating and/or programming of funds and administration of the Transportation Development Act of 1971 (TDA), as amended thereafter; and

WHEREAS, the County of El Dorado, the City of Placerville, and the El Dorado County Transit Authority are each required to file annual transportation claims for the funds, if any, from the Local Transportation Fund (LTF), the State Transit Assistance Fund (STA) and the State of Good Repair Fund (SGR) of the Western Slope of the County, as apportioned to them by the EDCTC, pursuant to the TDA; and

WHEREAS, it is the responsibility of the EDCTC, under the provisions of the TDA, to review the annual transportation claims and to make allocations of monies from the LTF, STA, and SGR funds based on the estimated revenue upon approving said claim; and

WHEREAS, the Auditor of said County is instructed to pay monies in the fund to the claimants pursuant to allocation instructions received from the El Dorado County Transportation Commission; and

WHEREAS, the County Auditor issued a report of estimated revenues for LTF for Fiscal Year (FY) 2026/27 and the State Controller's Office issued a report of estimated revenues for STA and SGR Funds.

NOW THEREFORE, BE IT RESOLVED, that the El Dorado County Transportation Commission shall review the claims as they are received, approve same for the FY 2026/27 funds estimated to be available in the LTF, STA, and the SGR funds, and make the following allocations:

1. To the El Dorado County Auditor-Controller for administrative costs in the amount of \$12,000, per Section 99233.1.
2. To the El Dorado County Transportation Commission for TDA administration and for planning and programming including the annual payment to SACOG per the 2024 EDCTC and SACOG Memorandum of Understanding in the amount of \$753,832, per Section 99233.1 and 99233.2.
3. To the El Dorado County Transportation Commission to allocate funds to an operational contingency in the amount of \$15,000.00.

4. To be reserved by the El Dorado County Auditor’s Office for future reimbursements to the City and County for pedestrian and bicycle facilities as programmed and claimed in the amount of \$137,949.56, per Sections 99233.3 and 99234.
5. Maintain the Local Transportation Fund contingency in the amount of \$4,000,000.00 for future transit needs. There is no additional allocation for FY 2026/27.
6. To the El Dorado County Transit Authority for Article 4 purposes, the total amount available of \$6,653,232.44 per Sections 99233.8, 99260(a), and 99262.
7. State Transit Assistance Funds – To the El Dorado County Transit Authority for State Transit Assistance Funds in the estimated amount of \$1,722,451 plus interest, for capital improvements, per Section 99314.6. This allocation is to be paid out by the County Auditor as FY 2026/27 revenues are received and available for payment.
8. State of Good Repair Funds – To be reserved by the El Dorado County Auditor’s Office for future reimbursements to the El Dorado County Transit Authority for State of Good Repair Funds in the estimated amount of \$337,624 plus interest. 3. State of Good Repair (SGR) from a portion of the Transportation Improvement Fee included in Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017

The El Dorado County Transportation Commission (EDCTC) is the Regional Transportation Planning Agency responsible for apportioning and administering these funds for this region.

DISCUSSION

EDCTA has submitted a TDA claim for FY 2026/27 requesting \$6,653,232.44 in LTF and \$1,722,451 in STA for a total of \$8,375,683.44. The TDA claim will be on the El Dorado County Transit Authority Board of Directors agenda for the May 1, 2026 meeting. The LTF and STA funds will be paid by the El Dorado County Auditor's Office to EDCTA as the funds are received. The estimated FY 2026/27 SGR funds are \$337,624 and will be reimbursed to EDCTA after approval by the Commission of a claim for an approved SGR project.

REQUESTED ACTION

Approve the Final Next Generation Transportation Investments Strategy.

BACKGROUND

The El Dorado County Transportation Commission (EDCTC) was awarded \$217,124 in Sustainable Communities Competitive Grant funding to prepare the Next Generation Transportation Investments Strategy (Next Gen Strategy or Strategy) to provide data, analytics, and information to support transportation investments across the western slope of El Dorado County. Changes in transportation funding policies at the state and federal levels combined with a paradigm shift in performance outcomes toward equity, adaptation and resiliency, and combating climate change have presented new challenges in the regional transportation planning space. Consequently, EDCTC is ever more challenged by these performance metrics due to low population densities, expansive geography, and widely dispersed disadvantaged cohorts, each of which are key metrics in all transportation funding programs. To overcome some of these challenges and develop a data-driven, performance-based transportation investment strategy which aligns with these new policies and performance outcomes, EDCTC pursued Caltrans Sustainable Transportation Competitive Grant funding to work with proven subject area experts. This will support EDCTC efforts to advance statewide goals related to land use, multi-modal transportation, climate and equity, and continue to deliver transportation projects that meet the needs of today's rural residents.

DISCUSSION

The Final Next Gen Strategy is the culmination of a two-year planning effort led by EDCTC in coordination with a consultant team, jurisdictional partners, and stakeholders. The process included robust public and agency engagement, incorporating targeted outreach strategies to ensure broad participation. A key component of this outreach was the launch of the Social Pinpoint online engagement platform in October 2024, which remained active through early 2025. This tool provided an accessible and interactive forum for community members to identify transportation issues, map concerns, and share input on priorities across the western slope.

The Strategy establishes an updated framework for evaluating and prioritizing transportation investments. At its core, the Next Gen Strategy is designed as both a planning and project prioritization tool. It is intended to:

- Support project identification and prioritization for future transportation investments
- Serve as a reference for EDCTC and partner agencies in preparing competitive grant applications
- Inform the Regional Transportation Plan (RTP) and related planning efforts, particularly in the areas of performance measurement, climate resiliency, and equity
- Integrate key policy considerations and data into a cohesive planning framework
- Provide an interactive mapping platform to visualize transportation needs, support public engagement, and monitor project development over time

Technical analysis prepared for the Next Gen Strategy includes an evaluation of existing travel patterns, vehicle miles traveled, greenhouse gas emissions, and the role of major corridors such as US 50 and State Route 49 in serving both local and regional travel demand. The analysis also examines climate vulnerability, disadvantaged community considerations, and emerging mobility trends, including the growth of electric vehicles, microtransit, and opportunities to support compact development patterns that may reduce trip lengths and expand multi-modal travel options.

These analyses collectively inform a performance-based project evaluation framework that incorporates metrics related to mobility, safety, resilience, equity, and project readiness. The Strategy also includes a high-level financial overview identifying potential funding sources to support implementation.

The Draft Next Gen Strategy was presented to the Commission at the April 2026 meeting. Staff incorporated a series of refinements and updates in response to Commission direction, stakeholder input, and additional technical review. These changes include:

- A link and background information on the County's Office of Wildfire Preparedness and Resilience Interactive Fire Prevention Mapping Application
- A link and background information on the Greater Placerville Wildfire Evacuation Preparedness, Community Safety, and Resilience Study
- Information about the County's ongoing Broadband Efforts
- Additional information regarding recreational trips to the Rubicon Trail through Georgetown/Wentworth Springs Road
- An updated map and enhanced information related to crash history on Salmon Falls Road

The Next Gen Strategy provides EDCTC with a comprehensive, forward-looking framework to guide transportation investment decisions on the western slope. By integrating data-driven analysis, community input, and alignment with evolving policy direction, the Strategy strengthens the Commission's ability to advance projects that improve mobility, enhance system resilience, and compete effectively for limited transportation funding.

The Strategy, along with its accompanying interactive mapping tools, positions EDCTC and its partners to make informed, transparent, and strategic investment decisions in the years ahead.

REQUESTED ACTION

Adopt Resolution 25/26.18 (Attachment A) allocating \$298,480 in Fiscal Year (FY) 2025/26 California Low Carbon Transit Operations Program Funds to the El Dorado County Transit Authority (EDCTA).

BACKGROUND

The Low Carbon Transit Operations Program (LCTOP) is one of several programs that are part of the Transit, Affordable Housing, and Sustainable Communities Program established by the California Legislature in 2014 by Senate Bill 862. The LCTOP was created to provide operating and capital assistance for transit agencies to reduce greenhouse gas emissions and improve mobility, with a priority on serving disadvantaged communities. Approved projects in the LCTOP will support new or expanded bus or rail services, expand intermodal transit facilities, and may include equipment acquisition, fueling, maintenance, and other costs to operate those services or facilities, with each project required to reduce greenhouse gas emissions.

DISCUSSION

El Dorado County Transportation Commission (EDCTC) received notification of FY 2025/26 LCTOP allocation amounts in the State Controller's Office letter dated February 27, 2026. As the Regional Transportation Planning Agency, it is EDCTC's role to allocate LCTOP funding to each project sponsor under the authority of EDCTC. According to Public Utilities Code (PUC) 99313, EDCTC's allocation for FY 2025/26 LCTOP is \$298,480. EDCTA's PUC 99314 allocation for FY 2025/26 is \$20,171, for a combined total of \$318,651. Since EDCTA is the only transit operator in the EDCTC region, staff recommends the PUC 99313 funds be allocated to EDCTA for the implementation of eligible projects, consistent with the FY 2025/26 LCTOP Guidelines.

EDCTA plans to use the combined \$318,651 in FY 2025/26 LCTOP funds to deliver two (2) projects that are consistent with LCTOP program guidelines and are based on recommendations contained in the 2024 Western El Dorado County Short Range Transit Plan Update – Service Development. The projects are:

1. The continuation of the Reduced and/or Free Fares project.
2. The continuation of the expanded Sacramento Commuter Service.

Per the LCTOP FY 2025/26 Program Guidelines, the continuation of free or reduced fare programs for fixed-route services and the continuation of expanded commuter services to increase transit mode share are both eligible projects. Per California Public Utilities Code Section 75230 (m), a recipient transit agency that uses LCTOP funds for the continuation of a free or reduced fare transit program may use LCTOP funds for that purpose without any restriction on length of time. However, the guidelines state that "if the Lead Agency needs multiple years of LCTOP funding for a project, it may accrue a maximum of 4 years of LCTOP funding for a single operating or capital project or

phase of a project.” El Dorado Transit's continuation of the expanded Sacramento Commuter Service, including operating costs, maintenance, and staffing, is consistent with LCTOP 2025/26 Program Guidelines.

The estimated annual cost for continuation of the free and/or reduced fare fixed-route program is \$50,000 and the estimated annual cost of the continued Sacramento Commuter Service expansion is \$268,651. Subject to approval by Caltrans Division of Rail and Mass Transportation, El Dorado Transit will utilize the combined \$318,651 in FY 2025/26 LCTOP PUC 99313 and PUC 99314 funding for these two projects. In addition to the resolution, the LCTOP Contributing Sponsoring Agency Letter (Attachment B) is also included which will be submitted as part of the allocation package.

WHEREAS, EDCTA is the Lead Agency for the two projects; the continuation of the Reduced and/or Free Fares project and the continuation of the expanded Sacramento Commuter Service; and

WHEREAS, the EDCTC wishes to delegate authorization to execute documents and any amendments thereto to the EDCTA Executive Director for Fiscal Year 2025/26 LCTOP funds; and

WHEREAS, the EDCTC acknowledges that the fund recipient, EDCTA, agrees to comply with all conditions and requirements set forth in the Certification and Assurances document and applicable statutes, regulations, and guidelines for all LCTOP funded transit projects.

NOW THEREFORE, BE IT RESOLVED, that the EDCTC approves the programming of \$298,480 in LCTOP Funds to the EDCTA to contribute to the delivery of two projects that are consistent with LCTOP program guidelines and are based on recommendations contained in the 2024 Western El Dorado County Short Range Transit Plan Update – Service Development.

1. Continue the Reduced and/or Free fares project
2. Continue the expanded Sacramento Commuter Service.

Division of Rail and Mass Transportation,

The El Dorado County Transportation Commission (EDCTC), as the Regional Transportation Planning Agency for Western El Dorado County, is eligible for the PUC 99313 allocation for the region. El Dorado County Transit Authority (EDCTA), as the region's transit operator, is eligible for the PUC 99314 allocation. As the sole transit operator within EDCTC's jurisdictions, EDCTA serves as the "Lead Agency" for LCTOP transit services and projects. EDCTC, therefore, serves as the "Contributing Sponsor" to the Lead Agency.

Per the State Controller's Office apportionment letter dated February 27, 2026, EDCTC's FY 2025-26 PUC 99313 allocation is **\$298,480**, and EDCTA's FY 2025-26 PUC 99314 allocation is **\$20,171**.

EDCTC is allocating all PUC 99313 LCTOP funds to EDCTA for projects consistent with the LCTOP program guidelines as well as the 2024 Western El Dorado County Short Range Transit Plan Update – Service Development.

For FY 2025-26, EDCTA is requesting to allocate the combined LCTOP PUC 99313 and PUC 99314 funds total of **\$318,651** to two (2) projects:

- Support the continuation of a free and/or reduced fare program (\$50,000)

SUBJECT: CONGESTION MITIGATION AIR QUALITY FUNDING REVISED PROGRAMMING TO THE EL DORADO TRAIL HALCON TO PONDORADO SEGMENT

REQUESTED ACTION

1. Adopt Resolution 25/26.19 (Attachment A) programming \$231,204 in Congestion Mitigation Air Quality (CMAQ) funding to the El Dorado Trail Halcon Road to Pondorado Class I project.
2. Supersede Resolution 22/23.04 (Attachment B) programming \$223,000 in CMAQ funds to the El Dorado Trail Halcon Road to Pondorado Class I project.

BACKGROUND

Prior to the Caltrans corrective action that went into effect in June of 2023, El Dorado County Transportation Commission (EDCTC) was responsible for the programming of federal CMAQ funds to projects or programs. The CMAQ program supported transportation projects or programs that demonstrated proven air quality emission reduction benefits by reducing congestion or vehicle emissions through transit services, congestion management, or active transportation. In accordance with Federal Guidelines, programming of CMAQ funds must consider quantitative data that demonstrate a project's emissions reduction benefits.

DISCUSSION

During the Call for Projects for CMAQ funding completed by EDCTC in August 2022, the Commission approved the re-programming of carryover funding from the Merrychase/Country Club Drive Bicycle and Pedestrian Project to the El Dorado Trail Halcon – Pondorado segment. At the time the anticipated de-obligated funding amount was \$223,000. However, the final amount was \$8,204 higher at \$231,204. To accurately reflect the increased de-obligated amount in EDCTC, SacTrak, and Caltrans accounting records; EDCTC is recommending adoption of Resolution 25/26.19, superseding Resolution 22/23.04, to correctly account for the increase in the de-obligated funding amount.





SUBJECT: FISCAL YEAR 2026/27 FINAL OVERALL WORK PROGRAM AND BUDGET

REQUESTED ACTION

Adopt Resolution 25/26.20 (Attachment A), approving the Fiscal Year (FY) 2026/27 Final Overall Work Program and Budget (Attachment B).

BACKGROUND

The Overall Work Program (OWP) and Budget is the annual work plan for the El Dorado County Transportation Commission (EDCTC), and it identifies the work activities and budget by work element for the upcoming fiscal year.

DISCUSSION

The Draft OWP was presented at the February Commission meeting and submitted to Caltrans for review and comments. The following changes were made to the Final OWP and Budget:

1. Caltrans requested additional language and changes to summary sections and some work elements in the OWP document. The requested changes are included in the Final OWP.
2. The budget includes a cost-of-living adjustment (COLA) of 2.5% for all positions except the Executive Director and Fiscal Officer, in accordance with the EDCTC’s Personnel Policies and Procedures Manual, Section 8.4.4, Annual Cost-of-Living Adjustments. Per the Policy, the increase in the Department of Labor, Bureau of Labor Statistics, Consumer Price Index for the Western Region was used to establish the COLA from December 2024 to December 2025.
3. Personnel costs were changed for the Executive Director, Fiscal Officer, and Principal Transportation Planner based on the salary adjustments approved at the March 5, 2026 Commission meeting.
4. The annual amount to SACOG increased \$3,296 due to the Consumer Price Index increase per the MOU.
5. The Freeway Service Patrol program increased \$8,000 due to a new contract and increased fuel costs.

The revenue in the FY 2026/27 budget equals the total expenditures. There is carryover funding that will be reserved for future planning efforts or grant match funding:

- STIP Planning Programming & Monitoring \$70,000
- Surface Transportation Block Grant Exchange \$270,000

The Final Budget was reviewed in detail with Chair Parlin and Vice Chair Clerici on May 6, 2026. The total amount of the FY 2026/27 Final OWP and Budget is \$1,640,970.11, an increase of \$50,119.
